Dear Governor Brown:


BRIDGE Housing enthusiastically supports the "by right" density proposal you put forward in the May budget statement.

BRIDGE Housing is the leading non-profit affordable housing developer in California. We create high quality, affordable homes for working families and seniors with a range of housing types that not only fit comfortably into their surroundings but also as the catalyst for revitalizing and strengthening neighborhoods. Based on our extensive experience developing affordable housing here in California we have firsthand experience with how a "by right" process would expedite the creation of affordable housing, as well as spur the development of other housing. It would reduce if not eliminate the risks associated with building critically needed housing in the State.

Currently, many Californians are facing impossible choices due to the lack of affordable housing, especially near places of employment. It is imperative that new processes be established that will result in the creation of more housing as quickly as possible. As an example, we are just completing the construction of a 115-unit affordable family rental development across the street from the San Leandro BART station. Approximately 28,700 people asked to be put on the interest list for these units that will be available in August 2016. In addition, more than 10,000 actually applied for the 158 affordable family units we completed in Oakland earlier this year. These are just two examples of the crisis that is facing so many Californians.

Your "By-Right" proposal would:

- ✓ Expedite the construction of housing in California
- ✓ Reduce the risks associated with getting housing entitled and constructed
