Dear President Obama:

On behalf of the National Hispanic Leadership Agenda (NHHLA), the coalition of the nation's 40 leading Latino advocacy organizations, we write to thank you for designating the Stonewall National Monument as the newest addition to the National Park System. As we urged you to do in our June 1, 2016 letter regarding the upcoming centennial of the National Park Service, this designation is an important step toward ensuring that the diverse stories and contributions of *all* Americans are preserved.

The Stonewall National Monument will be an enduring reminder of a key moment in the struggle toward equality for lesbian, gay, bisexual, transgender, and queer (LGBTQ) people in America.

We are particularly proud of the leading role that Latino/as and other LGBTQ people of color played in the 1969 rebellion at Stonewall Inn, such as transgender activists Sylvia Rivera and Marsha P. Johnson, among many others. It is our fervent hope that the contributions and leadership of LGBTQ people of color will be not become marginalized in the historical commemoration of this seminal event. The early narrative surrounding the tragic Pulse nightclub in Orlando shows how easily people of color can be marginalized and even rendered invisible in the telling of LGBTQ history – even in one so recent.

As NHHLA recommends in our 2016 Hispanic Public Policy Agenda, more national monuments are needed to tell the history of Latino/as in America. By designating the Stonewall Inn as a National Monument, you are not only acknowledging the rich history of the LGBTQ civil rights movement, but you are paying tribute to the persons of color who were integral to this activism. Too often, the LGBTQ community is thought of as distinct from other communities, leaving the stories, struggles, and sacrifices of LGBTQ people of color untold and marginalized.

We appreciate that the video announcing this designation included voices of LGBTQ people of color and encourage your Administration to continue to accurately and intentionally tell the story of our great nation in a fully inclusive
