Yeshua's Footprints 2020 - Israel Tour

June 8 - DEPARTURE

Your journey begins when you depart the USA on your overnight international flight. Meals served in flight.

June 9 - ARRIVAL

Welcome to Israel! Upon arrival in Tel Aviv you will be greeted by your guide and transferred to your hotel in Nazareth for dinner and a good night's rest.

June 10 - CAESAREA MARITIMA / MEGIDDO / CAESAREA PHILIPPI / NAZARETH (MT. PRECIPICE)

Journey to **Caesarea by the Sea** and stand in the place where it is believed Paul addressed King Agrippa and Festus. This port city reveals many extensive remains of the theater and other sites, including a Roman aqueduct along the Mediterranean shore. Travel the ancient caravan route to **Tel Megiddo**, an exciting archaeological dig with its layers of twenty different cities built on top of each other. Visit **Caesarea Philippi**, where Jesus traveled with His disciples and where nearby Peter made his great confession to Jesus, "Thou art the Christ, the Son of the living God". View **Nazareth**, the boyhood home of Jesus from the Mount of Precipice, where Luke describes how Jesus was rejected by those in the synagogue after He taught them. Filled with anger, they "led Him unto the brow of the hill whereon their city was built, that they might cast Him down headlong."

June 11 – CAPERNAUM, MT. OF BEATITUDES, BOAT RIDE, YARDENIT JORDAN RIVER BAPTISMAL SITE

After enjoying the Israeli buffet breakfast, spend most of your day around the Sea of Galilee. Enter the 2,000 year old remains of **Capernaum** and stand in what is left of the synagogue in which the Lord ministered. Visit the traditional site where Yeshua preached His Sermon on the Mount, the **Mount of Beatitudes**. Look over **Kursi**, where Jesus cast out evil spirits from a demon possessed man and sent them into a group of swine. Enjoy a beautiful boat ride across the **Sea of Galilee**. Finally, gather at the **Jordan River** for a time of spiritual blessing.

June 12 – BEIT SHEAN, JORDAN VALLEY, QUMRAN, SAMUEL'S MOUNTAIN, JERUSALEM

Stop at the ancient Roman city of **Beit Shean** where the bodies of King Saul and his sons were hung following a battle and their deaths. Travel through the **Jordan River Valley**, the route often taken by Jesus and other Galileans as they traveled to and from Jerusalem. Walk the remains of an ancient community near the shores of the Dead Sea at **Qumran**. Visit **Samuel's Mountain**. Transfer to **Jerusalem** for overnight.

June 13 - MT. OF OLIVES / CRUCIFIXION SITE / PATER NOSTER CHURCH / GARDEN OF GETHSEMANE / BETHLEHEM (SHEPHERDS' FIELD) / POOL OF BETHESDA.

Stand on the **Mount of Olives** for a remarkable view of the "Golden City" of Jerusalem, and consider that this is the final place Jesus stood before ascending into heaven forty days after His resurrection. Visit the **Church of Pater Noster**, where the Lord's prayer can be read in 62 different languages. Pray as Jesus did in the **Garden of Gethsemane** among the olive trees in the Kidron Valley, just across from the walls of Jerusalem. Visit **Bethlehem**, the place of Jesus' birth. Nearby, you will view **Shepherds' Field** where the Good News was first heard. View the **Pool of Bethesda** (John 5:1-31) where Jesus performed the Sabbath miracle. Visit Herod's Antonia Fortress where Jesus was brought before Pontius Pilate.

June 14 - MASADA, EIN GEDI, DEAD SEA

Enjoy a visit to intriguing **Masada**, the spectacular mountaintop fortress built by Herod that later became the final tragic stronghold of the Jewish rebellion against the Romans. Ride the cable car to the top to explore the fortress and look down upon the remains of the Roman camps and siege ramp below. Visit **Ein Gedi**, where David sought refuge from Saul. On the way back to Jerusalem, stop at the shores of the **Dead Sea**, the lowest spot on earth, for an opportunity to take a quick dip in the mineral laden waters.

June 15 – YAD VASHEM, WESTERN WALL, OLD CITY TOUR, CITY OF DAVID, CARDO, SOUTHERN STEPS, POOL OF SILOAM Walk the museum and grounds of Yad Vashem, Israel's Holocaust Memorial, with its poignant exhibits honoring the millions of lives lost during the Holocaust. Say a prayer at the Western Wall. Walk through the Old City and enjoy the preserved, ancient culture found in the narrow streets. Wander through the excavations of the City of David. Continue your journey through the Old City to the Cardo. This ancient marketplace has ruins that date back to the Judean monarchy mingled with modern shops. Visit the Davidson Center and the Southern Wall Excavations including the Teaching Steps and the Western Wall. Stand on the steps of the Pool of Siloam, where Jesus healed the blind man.

June 16 - VALLEY OF ELAH, JOPPA OLD CITY

Today journey through the **Valley of Elah**, where David defeated Goliath. Drive through Biblical Joppa, now the port city of **Jaffa**. Tel Aviv was founded on the outskirts of the city in 1909 and today surrounds the entire city.

June 17 - USA

Return home with a transformed faith and memories to last a lifetime! Meals served in flight.



Messianic Rabbi Zev Porat

Messianic Rabbi Zev Porat, founder of Messiah of Israel Ministries, was born in Israel into a Sanhedrin's family and raised in Bnei Brak, one of the most Jewish Orthodox cities in Israel. His grandfather, Rabbi Pinchas Porat, was a holocaust survivor who later became one of the heads of the Sanhedrin in Israel. Certified as a Jewish rabbi, Zev never truly experienced the presence of God and drifted away from Judaism. But that all changed when Zev had a number of supernatural encounters that brought him to the faith in Messiah Yeshua (Christ Jesus). Led by the Holy Spirit, Zev founded Messiah of Israel Ministries, one of the very few Messianic congregations actively preaching the Gospel publicly in Israel today. Over the many years, Messiah of Israel Ministries has been

reaching holocaust survivors, IDF soldiers, discipleship programs (Messianic congregations), and much more with the truth of Messiah Yeshua.

Zev teaches from a unique Biblical Hebrew foundation perspective of our faith in Yeshua, and how we can prepare ourselves as the Bride, to meet Yeshua the Messiah in the second coming. Zev is the Correspondent and Co-Host of Freedom Friday with Host, Pastor Carl Gallups, and has been heard nationally and internationally on Alfa Omega TV (Europe), CBN TV (Europe), Skywatch TV (USA), Prophecy in the News TV (USA), CBN TV (Europe), Asian Christian Network TV, EFR Christian German TV and Radio, as well as many other radio and television programs globally. He has also been interviewed numerous times on the TV program, "Why Israel," hosted by Rabbi David Naggi, which airs on Alfa Omega TV, TBN, as well as other networks in Europe.

Interesting Facts

Zev earned a Rabbinic Sanhedrin certificate from the Ponevezh Yeshiva (school for Rabbis) in Bnei Brak, Israel. Glory to Yeshua, after Zev got saved, he returned the certificate to the Yeshiva. Later, Zev became an ordained Messianic Rabbi (Pastor). He leads many Messianic house groups in Israel, and daily ministry outreaches in Synagogues and Mosques throughout Israel, which has resulted in many Jews and Arabs coming to the knowledge of Messiah Yeshua (Jesus) as Lord and Savior. He has shared the message of Yeshua through the Biblical Hebrew Foundation around the world, including the underground congregations in China, assisting in the establishment of over 100 congregations in Asia.

Carl Gallups has been a senior pastor since 1987. He is also a critically acclaimed Amazon Top-60 best selling author. He is a frequent preacher at Bible and prophecy conferences, and a frequent media guest commentator on TV, radio, and in print. He serves on the Board of Regents at the University of Mobile (AL).
