For any Saint Edward's School overnight domestic or international field trip or athletic trip, participating students and their parents/legal guardians ("Parents") must review the information in this packet and sign and submit Forms A-F, as applicable, including, without limitation, Form A "Participation Assumption of Risks and Waiver and Release from Liability."

Be aware that these forms have important legal consequences. Do not sign them unless you have read them and know what they mean. Consult your legal counsel for assistance.

- Form A: Participation Assumption of Risks and Waiver and Release from Liability.

- **Form D** and **D2**: Insurance Information and Personal and Supplemental Insurance Forms.

Saint Edward's School, Inc. <u>Participation Assumption of Risks</u> <u>and Waiver and Release from Liability</u>

Form A

Please read this document carefully. It affects the legal rights of the Student and the Student's parents and/or legal guardians, as applicable, (the "Parents") related to the Student's participation in the Event described in the attached Event Description – Schedule 1 ("Event"). **Participation in the Event is voluntary**.

Please call to speak with the appropriate Division Head to discuss any questions about the Event, this Agreement, or any of its provisions, or incorporated Forms. Please also consult your legal counsel for help to make sure you understand this Agreement and all applicable Forms.

This Participation Assumption of Risks and Waiver and Release from Liability incorporates by reference the Event Description attached hereto as Schedule 1 and the applicable Forms A-F all of which are made a part hereof.

A Student who is 18 or older who signs this Agreement represents that he or she has received the opportunity (and been strongly encouraged) to review this Agreement (and the applicable incorporated Forms) with an attorney, has carefully read and fully understands the contents of this Agreement (including the applicable incorporated Forms), that he or she understands the activities and risks of the Event, whether or not described on Schedule 1, and chooses to participate in the Event, understands that he or she is legally bound by this Agreement, and that he or she is giving up substantive legal rights.

A Student who is under the age of 18 years who signs this Agreement acknowledges that he or she has read and discussed this Agreement (including the applicable incorporated Forms) with his or her Parents, that he or she understand the activities and risks of the Event, whether or not described in Schedule 1, and chooses to participate in the Event, and understands that by signing this Agreement he or she is, to the fullest extent permitted by law, legally bound by this Agreement and giving up substantive legal rights.

Regardless of the Student's age, all of the participating Student's living parents and/or legal guardians, as applicable, are required to sign this Agreement, unless the School has granted a specific written exception due to unusual circumstances.

In consideration of the Student being allowed to participate in the Event, and understanding that Saint Edward's School, Inc. (the "School") is a non-profit educational institution, we, the Student and the Parents, acknowledge and agree as follows:

Risks and Acknowledgments

By signing this Agreement, we acknowledge and agree that (1) we have read and understand Schedule 1; (2) we are aware of and understand fully the risks to the Student personally and to the Student's property, which may result in the Student's serious or permanent bodily injury or death, and we understand that the risks to the Student can be a consequence not only of the Student's acts or omissions but also of the actions or negligence of the School (including its staff, employees, coaches, volunteers, chaperones, agents, representatives or any other of the Released Parties as defined below), other participating students or adults, independent contractors or third parties, or travel conditions, transportation, or equipment; (3) we are responsible for requesting any additional information we need to determine whether the Student will participate in the Event, and for determining the Student's suitability for participation in the Event; and (4) the School's staff has been available to answer questions about the nature and demands of the Event and its inherent and other risks.

We further acknowledge and understand that travel generally, activities associated with travel, and the Event have inherent risks that cannot be eliminated without changing or destroying the nature of the activities and the Event. We understand that we are responsible for investigating and evaluating the risks that the Student may face, including but not limited to inherent risks.

The Student and his/her Parents, on behalf of their minor child and for themselves, agree that any activities the Student may take part in, whether as a component of the Event or separate from it, will be considered to have been undertaken with the Student's and his/her Parents' approval and understanding of any and all risks involved. Each of the Releasors (as defined below) assume full, sole, and complete responsibility for ALL RISKS, inherent and otherwise, known and unknown, whether or not described in Schedule 1, including without limitation, risks of, death, personal or bodily injury, disability and/or property damage resulting from, in connection with, or in any way related to, Student's participation in the Event.

If the Student is a minor, we acknowledge that we have read and discussed with each other this Agreement and the Event, including, without limitation, the inherent risks of the Event, and the Student understands the activities and risks and, with the consent of his/her Parents, voluntarily chooses to participate.

We represent and warrant to the Released Parties, that all of Student's living parents and/or legal guardian(s), as applicable, have duly signed this Agreement (unless the School has granted a specific written exception due to unusual circumstances).

Waiver and Release from Liability/Indemnity:

We, the Student and Parents of the Student, jointly and severally, and intending to legally bind ourselves (Parents and Student) and all of our respective guardians, heirs, executors, personal and legal representatives, estates, beneficiaries,

administrators, successors and assigns (all of the foregoing, collectively the "Releasors"), do hereby waive, release and discharge, and promise not to sue, the School, and its officers, directors, trustees, shareholders, owners, managers, partners, employees, staff, coaches, volunteers, chaperones, and supervisors and their successors and assigns (collectively the "Released Parties") from any and all liability and/or claims, suits, damages, injury, disability, death, costs and expenses, whether arising before, during or after the Event, whether described in Schedule 1 or not, and whether caused by the sole or joint negligence, gross negligence, or tortious act or omission of the Released Parties, or any of them, or any third party (collectively the "Claims"). This Waiver and Release does not apply to the willful misconduct of the Released Parties. The Releasors hereby knowingly and voluntarily waive, to the fullest extent permitted by law, the benefits of any statute, law, rule, or common law which may limit the scope of this Waiver and Release.

We also hereby agree to indemnify, defend and hold harmless the Released Parties from any and all claims, liabilities and costs asserted by or on behalf of us or any of our legal representatives, heirs, successors and assigns within the scope of the release above. We agree to be financially responsible for any and all damages, costs or fees for which the School may be liable as a result of the conduct of Student.

If any part of this Waiver and Release, or if the whole Waiver and Release is found to be invalid, unenforceable, or void, for any reason, then the Releasors acknowledge and agree that the Released Parties' entire liability to the Releasors or any other person shall never, under any circumstances, be more than any applicable insurance limits, even if one or more of the Released Parties was negligent or grossly negligent. In addition, the Releasors acknowledge that none of the Released Parties shall ever be liable to any person for special, incidental, consequential, or punitive damages or for any indirect damages such as, but not limited to, exemplary damages or lost earnings, lost revenues or loss of consortium, or companionship (even if the Released Parties have been advised of the possibility of such damages) whether based upon statute, contract, tort, negligence, strict liability, or otherwise.

This Waiver and Release does not release, is not intended to release, and does not in any way apply or relate to the release and/or discharge of any claims Releasors may have against any person and/or party other than the Released Parties.

Conduct and Adherence to Standards:

The Student is subject to the School's rules and policies as set forth in School's Parent/Student Handbook, as well as to the rules and policies of any company, or organization that may be involved in the Event. We also understand and acknowledge that Student understands that Student must not engage in any inappropriate behaviors, violate safety guidelines, use inappropriate language, or otherwise engage in any behaviors that create even the appearance or impression of impropriety while participating in the Event. Consumption of alcohol is not permitted even if it is lawful for the Student to do so in the country in which the Student is traveling. No alcohol, drugs, or tobacco are allowed at any time. The

possession or use of weapons is strictly prohibited. Students may not operate motorized vehicles of any type. Additionally students may not participate in sexual activity at any time. A Student who violates the rules and policies or fails to comply with the instructions and guidance of the Trip Leader will be subject to School disciplinary action up to and including termination of participation in the Event and/or expulsion from the School.

If the Event involves international travel, the Student will be subject to the laws of the country in which the Student is traveling; in many foreign countries, the possession or use of illegal drugs is punishable by fine, imprisonment, and/or deportation.

Financial Obligations:

If there are additional fees for the Event, the Parents will pay amounts due by the specified date(s) and will abide by the School's refund policies on Event and travel fees as stated on Form B.

Student's Suitability to Participate in the Event:

We represent that (i) we have provided complete and accurate medical information to the School via the Health Information Forms, submitted at the start of school. (ii) Student has no medical condition (physical or mental) which would or could impact on the Released Parties allowing Student to participate in the Event and that the Student is physically able to participate in the Event, able to respond quickly to emergencies or other situations requiring a quick response, and does not present a risk or danger to himself or herself or to others; and (iii) Student is not taking any herbal or medicinal supplement or prescription that could impact on Student's participation in the Event.

Event Modification and Cancellation:

As provided on Form B, the School reserves the right to cancel or modify the Event before or during its operation for any reason.

Termination of Participation:

In its sole discretion, the School may terminate the Student's participation in the Event at any time. Reasons for termination may include, but are not limited to, conduct or other behavior by the Student inconsistent with the School's rules and policies as stated in School's Parent/Student Handbook or otherwise deemed detrimental to the best interests of the Event, emergencies, or health or safety conditions or considerations. As provided on Form B, if the School terminates the Student's participation because of the Student's misconduct, the School will require that the Parents either pick up or make arrangements for Students return home (at the Parents' sole cost and expense), and the School will not provide any refund.

Departure from the Event:

Students must plan to return with the Trip Leader and other participants at the end of the Event. The student may not take independent side-trips with other parties

and the student must adhere to the Event itinerary for the entire duration of the Event.

Governing Law; Forum and Venue:

This Agreement shall be construed in accordance with, and governed by, the laws of the State of Florida, notwithstanding its choice of law principles. We agree that any lawsuit arising out of or related to this Agreement or the Event or activities that are the subject of this Agreement must be brought and maintained only in Indian River County, Florida state or federal court (as appropriate) and we consent to jurisdiction in such court.

Severability: If any provision of this Agreement or the application thereof is held invalid, the invalidity shall not affect other provisions or applications of this Agreement which can be given effect without the invalid provisions or applications. To this end, the provisions of this Agreement are declared severable.

Construction and Scope of Agreement:

The language of all parts of this Agreement shall in all cases be construed as a whole, according to its fair meaning, and not strictly for or against us or the School. This Agreement, which includes Schedule 1 and the applicable forms B-G, is the entire and complete agreement between us and the School relating in any way to the subject matter hereof. This Agreement supersedes any earlier written or oral understandings or agreements between us and the School.

Signatures:

The Student and the Parents by signing below acknowledge that they (1) have carefully read this Participation Assumption of Risks and Waiver and Release from Liability, including without limitation, the attached Schedule 1 and the applicable related Forms, and fully understand their terms; (2) have received the opportunity (and been strongly) encouraged to review this Agreement with an attorney; (3) understand that by signing this Agreement the Student is, and the Parents are, on behalf of their minor child and for themselves, giving up substantial legal rights, as well as the rights of all other Releasors; (4) are aware that the description of risks associated with the Event is not complete and that other unknown or unanticipated risks may arise; (5) have asked and received answers to all questions he/she/they may have; (6) have not been induced to sign this Agreement by any promise or representation and sign it voluntarily and of their own free will intending and agreeing to be fully bound by the terms hereof; and (7) understand and acknowledge the Student's participation in the Event is purely voluntary and that they may choose to NOT allow Student to Participate in the Event in their sole discretion.

Schedule 1

We understand that Saint Edward's School's (the School) class of 2021 will be traveling to Clayton, Georgia for a 5 day, 4 night class trip on April 16 - 20, 2018 which will include two full days of travel by motor coach, two full days of White Water Rafting on the Chatooga River, and 1 day with a college visit to Clemson University and the Curahee Military History Museum.

We understand the students and 5 Saint Edward's chaperones (Terry Moody 317-702-1325), Shaun Hurley, Father Tommy Mathews, Chris Stephenson and Anthony Baron) will depart Saint Edward's property at approximately 6:00 a.m. April 16, 2018 and travel by professional motor coach. Students will arrive at Camp Dixie in Clayton, Georgia at approximately 6:00 p.m. Students will be placed in a group of students and required to remain with their group in a rotation of activities across the three days. Each group will have an assigned teacher/chaperone who will go raft with the students and go with them on the college visit/museum day. Students will be provided money for meals on the trip to and from Georgia. Breakfast and dinners will be provided at Camp Dixie. Lunch will be served on the rafting trip and at a dining hall on the visit day to Clemson University.

We understand that the entire group will spend 4 nights at Camp Dixie. Female students will be billeted 6-8 to a room with bunk beds. Male students will sleep in an open dormitory style room together with the male chaperones. Male and female students are not permitted in the rooms of the opposite sex at any time.

We understand that on each of three days beginning on Tuesday, April 17 and continuing through Thursday, April 19 students will be white water rafting the Chattooga River on two days and attending a visit to Clemson University and the Curahee Military History museum on one of the days. Students will travel by motor coach to and from Camp Dixie to and between these locations.

On the morning of Friday, April 20, 2018, students will rise early and be provided a sack breakfast. They will depart Camp Dixie at approximately 4:15 a.m. and travel back to the Saint Edward's campus by motor coach. They will arrive back to the Saint Edward's campus at approximately 5:00 p.m.

We understand that all meals during this trip will be provided as a part of the trip cost. Students may bring additional "spending money" for personal purchases such as additional snacks and drinks and souvenirs, etc. if they choose. Bringing large sums of money is discouraged. A detailed itinerary with times, dress code and recommended packing list is included in this packet.

We understand that School as well as the vendors will take every possible precautionary measure to ensure the safety, health and well-being of each participant. However, as with any form of transportation or activity there are

inherent risks. Such risks include but are not limited to motion sickness, sunburn, dehydration, stings, insect bites, cuts, scrapes, rashes, neck or back injuries due to to walking, riding buses or being outside, as well as minor injuries (e.g. scratches, bruises, and sprains, major injuries(e.g. eye injury or loss of sight, joint or back injuries, heart attacks, and concussions) and catastrophic injuries (e.g. paralysis or death). Risks from rafting can include bodily injury, disease, strains, fracture, partial and/or total paralysis, death or other ailments that could cause serious disability. These risk and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge the terrain, weather, trail or river route location, water level, risks of falling out of or drowning while in or out of a raft, canoe or kayak and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

We understand that the above description of the inherent risks may result in the participant's injury or death.

Expectations for Behavior

 - o Keep money and cell phones secure at all times
- Students should be on their best behavior

Saint Edward's School, Inc. <u>Acknowledgement of Off-Campus Event</u> and Travel Cancellation Policy

We understand that, although the School will attempt to maintain the Event as described in the Event Description (Schedule 1 to Form A), it reserves the right to cancel or change the Event for any reason. Such a decision is dependent on a number of factors including, without limitation:

1. Minimum enrollment levels for the Event.

Saint Edward's School sponsored events normally require a minimum participation of students at the registration deadline and thereafter in order to function. The Trip Leader will publicize this participation figure.

2. Conditions in-country or surrounding areas.

This includes, but is not limited to U.S. State Department travel warnings for the country where the Event will take place. For more information, visit the State Department site: http://travel.state.gov.

Cancellation Policy is as follows with regard to Event fees:

- 1. If Saint Edward's School cancels the Event, whether before or after it commences, the School will refund Event fees (including airfare), except those costs and fees that the School is unable to recover.
- 2. If Saint Edward's School does not cancel the Event but the Student chooses to withdraw from the Event for any reason, the Student and his/her parents/legal guardians will be responsible for covering all non-recoverable obligations.
- 3. If Saint Edward's does not cancel the Event, but terminates the Student's participation in the Event because of his/her failure to abide by all policies, rules, and regulations of the School or any company or organization involved in the Event, or all rules, regulations, and laws of the countries to be visited, or if School terminates the Student's participation in the Event because of the Student's inappropriate conduct, as determined by the Trip Leader(s) and/or Saint Edward's School officials, the Student and his/her parents/legal guardian are not entitled to any refund. Additionally, in such circumstances, the Student and his/her parents/legal guardian are responsible for costs of return transportation for both the student and an accompanying chaperone or the School may require the parents/legal guardians to pick up the Student from the Event.
