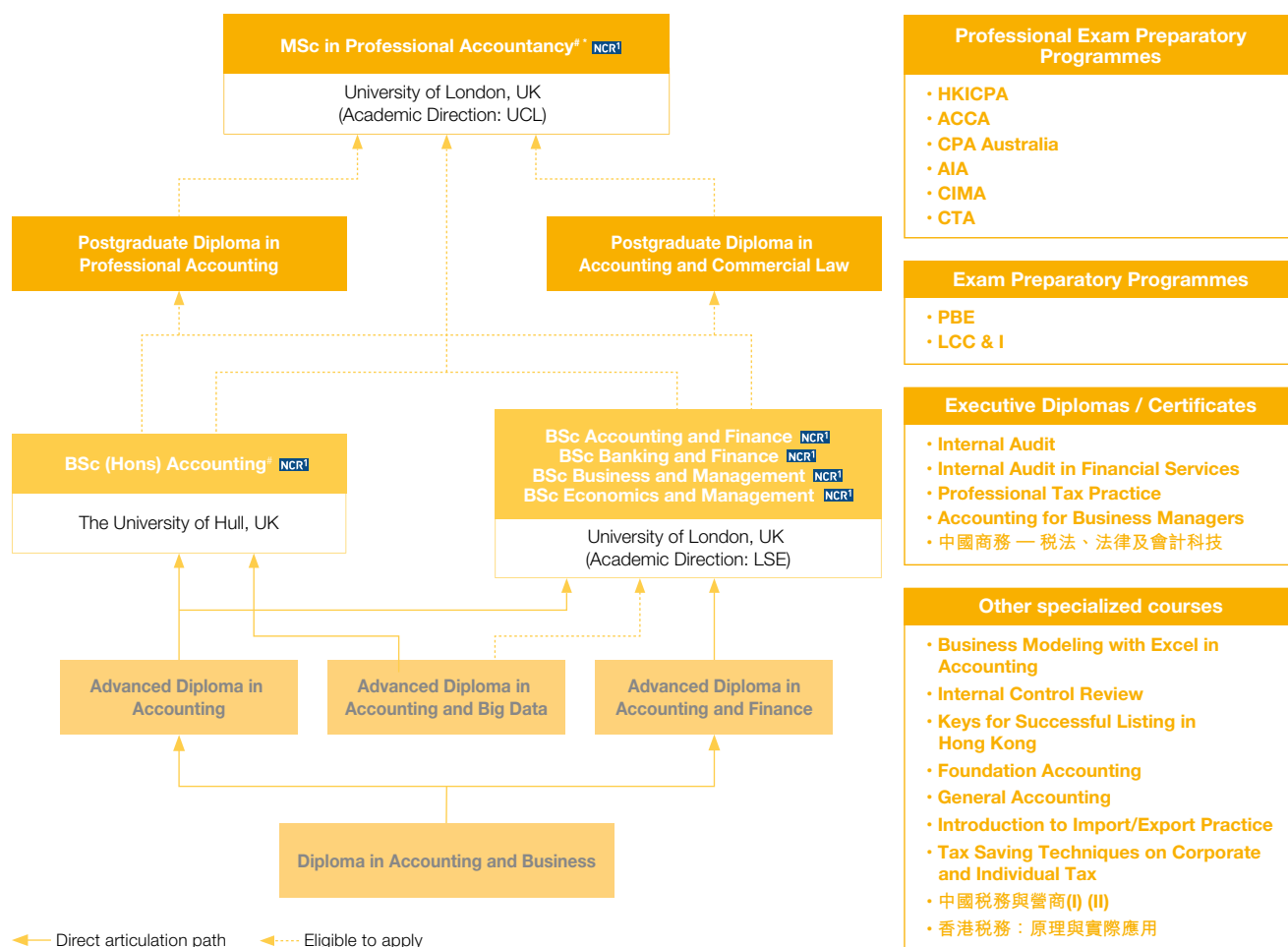

The MSc programme is led by UCL (University College London) which is ranked 7 in 2018 QS World University Ranking! (just after Oxford)

This preparatory course aims to provide tuition support to students of MSc in Professional Accountancy, University of London (UoL). This MSc programme provides students with an opportunity to develop and apply masters level knowledge, understanding and skills within accountancy and finance-related content.

**R** To apply for the Preparatory Course for MSc in Professional Accountancy, applicants must first register with UoL as students of this MSc programme and enrol in the relevant module(s).

### 1) Academic Requirements

#### A) MSc Pathway 1

To qualify to register for the MSc under Pathway 1, an applicant must be a current ACCA student with passes in all nine Applied Knowledge and Applied Skills papers and the two Strategic Professional Essentials (SBL and SBR).\*

#### B) MSc Pathway 2

To qualify to register for the MSc under Pathway 2 an applicant must be a current ACCA Member or Affiliate, with passes in all nine Applied Knowledge and Applied Skills papers, the two Strategic Professional Essentials (SBL and SBR) and two Strategic Professional options from AFM, APM, ATX and AAA.\*

#### C) Postgraduate Certificate

To qualify to register for the Postgraduate Certificate an applicant must be a current ACCA student with passes in all nine Applied Knowledge and Applied Skills papers.\*

### 2) English Language Requirements

A student will meet the English language requirement if they:

- have passed the English version of the nine ACCA Applied Knowledge and Applied Skills papers (or gained exemption by completing an English-language undergraduate degree approved by ACCA);
- have passed the English version of either of the Strategic Professional Essentials (SBL or SBR), or equivalent; OR
- are a current ACCA Member or Affiliate.
