Curse of the beer belly

Deep fat can incresase risk of serious health threats, doctors say

t 265 pounds, Tony Wells was fat, and he'd tell you the same thing. The 44-year-old IT man-

ager spent the better part of 10 years trying to get rid of his beer belly. But every time he closed in on a target weight, he'd hit a wall.

When he got frustrated, Wells would stop dieting and his belly would return, getting larger as summer cookouts brought brats, burgers and, of course, beer. According to a survey

from the National Institutes of Health, 74 percent of men age 20 and older are overweight or obese. But, despite the popular aphorism, beer has little to do with it.

The term beer belly is a bit of a misnomer, said Dr. Aaron Clark, a family physician at Ohio State University's Wexner Medical

"Beer can be one cause of a big belly, but just because of the calories in it," Clark said. "It's easy to over-consume calories in liquid form.'

However, the salty, fried foods and munchies that people often eat with beer play a larger role in causing a beer belly than the beer itself. Any excess calories will do.

It's also not an inherently male problem.

Women put on weight, too, said Dr. Michael Jensen, a professor of medicine at the Mayo Clinic, but they are more likely to gain fat in the hips and thighs.

"Hormones have a big effect," Jensen said. Why do many middle-age men struggle with beer

bellies? Jensen said the reasons are complex.

"Research suggests that beer belly is accumulating because things go wrong in other fat cells," he said.

The main cause of the typical beer belly is when the subcutaneous fat — the "healthy" fat found just under the skin — isn't working well. When that fat can't store

and burn fat properly, it gets stored in the visceral or "deep" fat that wraps around the liver, pancreas and intestines. This causes beer bellies, and it should be a cause for alarm. According to the Centers

for Disease Control and Prevention, excess fat can increase the risk of diabetes, high blood pressure, heart disease, breathing problems, depression and anxiety. The moment Wells real-

ized he needed to make a lifestyle change was after a Christmas party three years ago. "I saw a picture of myself," he said. "I was so bloated. I didn't even recognize myself. His knees ached. He


developed sleep apnea and heartburn. And he couldn't push himself to get off the couch.

"Sometimes, inertia sets in and people just feel overwhelmed at the possibility of changing an entire life-style," Clark said. Looking for a quick fix,

Wells tried several fad diets and "beach-body" workouts. They didn't work for him.

The bad thing about fad diets is not that people don't lose weight," Jensen said. "It's that they don't stick with it and they just regain all that weight they

lost. They're unsustainable." And when Wells started going to the gym, he had no idea what he was doing. He

started lifting weights and doing crunches, trying to attack his bulge.

But instead of losing weight, he gained muscle mass. His weight zoomed to 295 pounds.

Jensen said diet and exercise is the best prescription. High-intensity aerobic exercises such as running, biking and squats work best. Simply walking will


do, too.
"Just starting your workout is the hardest part," Wells said. "But once you start, it's easy to finish.'

His weight today is 240 pounds — most of it mus-


