ARTICLE I: STATEMENT OF WORK

1.1 Contractor will set up a new file with Dun and Bradstreet, provide an 80 Paydex score on the file of the client, and a minimum of three reporting trade lines totaling no less than \$40,000 combined.

1.2 It is fully understood and agreed that Contractor is an independent contractor and is not an agent, servant, or employee of the Client. Contractor declare that it is engaged as an independent business and has complied with all applicable federal, state, and local laws regarding business permits and licenses of any kind, including but not limited to any insurance coverage that is required in the normal course of business.

1.3 Contractor shall furnish professional services performed in accordance with standards necessary for the satisfactory performance of the work hereunder. . Contractor agrees that it does not have any authority to sign agreements, notes, and/or obligations or to make purchases and/or dispose of property for, or on behalf of, the Client.

1.4 Contractor shall furnish its own support staff, materials, tools, equipment, and other supplies necessary for the satisfactory performance of the work hereunder. Contractor shall be responsible for and assume all office and business expenses that are incurred as a result of the performance of this contract.

ARTICLE II: TIME OF PERFORMANCE

2.1 Contractor agrees that the client will receive an 80 paydex score listed with Dun and Bradstreet for _____ with three to four reporting trade lines totaling a minimum of \$40,000 combined, within approximately 15 business days from the client ordering the package recommended by the contractor from Dun and Bradstreet.

ARTICLE III: COMPENSATION

3.1 In consideration for the promises and performance of Contractor as set forth herein, the client agrees to pay the contractor \$4500 up front via wire transfer. The contractor reserves the right to place a derogatory mark on the Dun and Bradstreet file of the client in the event that monies due are not paid according to this agreement.

ARTICLE IV

This Contract and any claims arising out of this Contract shall be governed by the laws of the State of California. Any provision of this Contract prohibited by the law of California shall be deemed void and of no effect. Any litigation arising out of or relating in any way to this Contract or the performance there under shall be brought only in the courts of California, and the Contractor and Client hereby irrevocably consents to such jurisdiction.
