Stellalander-Delareyville - AfriForum se tak in die dorp het Dinsdag (30 Maart) die plaaslike begraafplaas begin skoonmaak.

Dit is deel van hul #VegEnBou-projekte.

Teen die tyd is die grafte nie meer sigbaar vanaf die ingang nie omdat dit toegegroei was onder bosse, onkruid en gras.

Dit het tot gevolg gehad dat inwoners vir lank nie die grafte van hul afgestorwe familieleden kon besoek nie.

Die lang gras maak dit selfs onveilig vir besoekers.

Volgens die organisasie het inwoners van die dorp – wat gebuk gaan onder swak dienslewering deur die Tswaing Plaaslike Munisipaliteit – besluit om die gemeenskap te nader en iewers in te gryp. Ondernemings, sakemanne en inwoners het bydraes gemaak en toerusting is bymekaargemaak vir dié groot skoonmaakprojek.

“Dit is weereens ’n bewys van die krag wat ons gemeenskappe het wanneer ons saam inspring en die selfdoenbeginsel toepas. Die agteruitgang van ons kleiner dorpie is duidelik sigbaar, maar wanneer inwoners só saamstaan gee dit vir almal weer hoop,” sê Gerhard Nieuwoudt, distrikskoördineerder vir Stellalander.

“Ons dorp gaan net verder verswak indien ons nie opstaan en terugveg teen agteruitgang nie. Selfdoenprojekte is al wat ons dorp gaan red. Dit wat na ’n onmoontlike taak gelyk het, is nou weer bereikbaar danksy AfriForum se veg-en-bou-strategie,” sê Rassie Taljaard, voorsitter van die Delareyville-tak.



Nuutste brandstofpryse

Stellalander-Vryburg – Indien jy hier lees, en nie teen Dinsdagaand middernag brandstog in jou voertuig gegooi het nie, gaan jy baie spyt wees - brandstof kos van Woensdag (7 April) af gemiddeld 'n R1 meer.

Gwede Mantashe, die minister van minerale hulpbronne en energie, het onlangs aangekondig dat wysigings in die petrolprys op die datum sal geld.

93-oktaan-petrol styg met 95c per liter, gevolg deur 95-oktaan-petrol met R1 per liter.

Diesel met 0,05% swael sal verhoog word met 65,2c per liter, terwyl diesel met 0,005% swael met 63,2c per liter opgaan.

Paraffien styg met 34,8c per liter en gas met 48c per kilogram. Daar is verskeie redes verskaf vir die aanpassing van dié pryse.

Volgens Mantashe het die prys van Brent ru-

olie van \$61.10 na \$64 per vat gestyg.

Nog 'n faktor wat 'n groot rol speel is die verhoging in internasionale pryse van petrol, diesel en paraffien.

Dit het onderskeidelik met 61.72c per liter, 27.22c per liter en 25,26c per liter gestyg.

Verder het die Rand/dollar-wisselkoers ook 'n impak gehad op die prys van brandstof. Die rand het teen die dollar verswak - van 14,76 tot 14,95).

“Die minister van finansies het op 25 Februarie in sy begrotingsrede aangekondig dat die brandstof- en padongeluksfondsheffing op petrol en diesel onderskeidelik met 16c per liter en 11c per liter sal verhoog vanaf 7 April,” het hy afgesluit.



TRAVEL UPDATE

Stellalander-Northwest - Several accidents have claimed life's of seven people since the 2021 Easter Road Safety Campaigns were launched by Deputy Transport Minister Magadzi on Monday (29 March).

These accidents occurred in different parts of the Northwest Province.

According to the spokesperson for the Department of Community Safety and Transport Management one accident was so horrific that a person was burnt beyond recognition.

MEC for the Department of Community Safety and Transport Management Sello Lehari sent messages of condolences to the bereaved families and wished speedy recovery to those injured.

He appealed to all road users to exercise patience. Recklessness, drunken driving and impatience appear to be main causes according to Northwest Traffic Department, Director Paul Stone.

"We can do all we can as law enforcement but until our people begin to drive responsibly

we will not reduce the carnage on our roads. As law enforcement we are going to apply stringent measures and will be intolerant to all those found in violation of traffic laws", said Mr Stone.

From Thursday (1 April) almost all arterial routes (N4, N12, N14, N18, R30, R34, and R52) experienced high volume of traffic. The law enforcement in the Province is however ready.

"We had 545 men and women on our roads. It is anticipated that traffic volume will pick up from Sunday afternoon to Monday. We are not slackening, 'we are not letting our guards down', it's 'arrive alive.

We will arrest anyone found on the wrong side of the law," warned, Chief Director of the Transport Regulations, Molefi Morule.

Truck overturns

Stellalander-Vryburg – A truck overturned on the road between Vryburg and Schweizer-Reneke here.

Die dodetal staan tans op 52 946 en minstens 1475 398 mense het reeds herstel.

Die herstel koers is tans 95%.

Altesaam 239 102 gesondheidsorgwerkers is teen 1 April reeds met die Sisonke protokol ingeënt.





Drie wat wreedaardig moor, gevonniss

Stellalander-Postmasburg - Die stasiebevelvoerder van Postmasburg SAPD, Lt kol Andries Witbooi, verwelkom die vonnisse wat onlangs aan drie beskuldigdes hier opgelê is.

Dit weens die wrede moord op Dick De Koker. Die uitspraak is op 26 Maart in die Kathu landdroshof gelewer. Volgens inligting beskikbaar het die voorval op 23 Maart 2019 by die Postmasburg Makoudam plaasgevind.

Die drie beskuldigdes het De Koker wreedaardig vermoor, sy leweloze liggaam veld toe gedra en dit aan die brand gestee. Lt kol Witbooi het die

ondersoekspan van die Postmasburg SAPD en speurder A/O Diphoko wat onverpoos gewerk het om die verdagtes wat die gruwelike misdaad gepleeg het, op te spoor en te verbind, bedank.

Twee van die drie beskuldigdes, Nico de Koker (31) en Tsokolo Olyne (28), is tot lewenslange gevangenisstraf gevonniss, terwyl Hendry Smith (33) tot 12 jaar gevonniss is.

Two dies in collision

Stellalander-Schweizer-Reneke – Two people were killed in a collision which took place on the road between Schweizer-Reneke and Vryburg.

The accident took place on Tuesday (30 March) at 17:50. It is alleged that a sedan travelling in the direction of Schweizer-Reneke overtook a convoy of vehicles. The sedan was allegedly travelling at a high speed. Three occupants, all men, aged between 22 -and 25-years-old were travelling in the sedan. In avoiding the oncoming traffic the speeding sedan wanted to get back in the left lane but it allegedly rammed into the truck which was among the overtaken vehicles. Two occupants were declared dead on the scene of the crash while the third succumbed to his injuries at a local hospital. Police are investigating a case of culpable homicide as well as negligent and drunken driving.



97 arrested during Easter weekend



Mpumalanga 400 results

Stellalander-Dullstroom - History was made at the recent Mpumalanga 400, the season opener of the 2021 South African National Cross Country Series (SACCS).

Lance Woolridge and Elvéne Vonk won the race which took place in the Dullstroom area.

The pair also clinched the FIA Class laurels and produced a maiden victory for the brand-new Ford Castrol Cross Country Team Ranger. With the first points in the overall Production Vehicle Championship as well as the FIA and T Class Championships in the bag for some, others, however, now face the uphill battle of fighting back to make up for lost ground. Looking at the overall rankings, Woolridge/Vonk (30 points) have taken the lead and are followed by the defending Class T champions and class winners of the 2020 and 2021 Mpumalanga 400, Johan and Werner Horn (Malalane Toyota Hilux). SACCS newcomer and multiple SA National Rally Champion Guy Botterill, deputising for reigning overall and FIA champion Henk Lategan, who is still recovering from a shoulder operation after a crash at the Dakar Rally. Reigning navigators' champion Brett Cummings (Toyota Gazoo Racing SA Hilux)

rounded off the overall podium and trail the Class T team by five points while they are 12 points behind the overall leaders. Giniel de Villiers/Dennis Murphy (Toyota Gazoo Racing SA Hilux) found themselves only one point ahead of Mark Corbett/Rodney Burke (Century Racing CR6) with the rest of the top ten consisting of two father and son teams, Johan and Sean van Staden (Moto-Netix KEC Racing Renault Duster) and Malcolm and Frans Kock (Neil Woolridge Motorsport Ford Ranger) in ninth place. There might be a bigger point's difference in the overall standings between the Class T teams, but the gaps are much smaller in the class championship. Here the Horn brothers (35 points) have a small margin of only seven points over the Kock father and son team (28 points) with the newcomers to the Production Vehicle category, Christo Rose/Arno Olivier (Neil Woolridge Motorsport Ford Ranger) a mere five points further back in third place from where they trail the leaders by 12 points. The second round of the 2021 SACCS championship, the Sugarbelt 400, is scheduled to take place on 21 and 22 May in KwaZulu-Natal and teams have seven weeks to prepare for this event.
