





Promoting Amarillo

Overall, Amarillo CVC Communications had an excellent year. We hosted several press trips this year, had clips in all major Texas outlets and hosted writers and received interest from around the world. Advertising equivalency remains over \$1 million.

Amarillo participated in the annual Travel Media Showcase in Grapevine, TX. The city hosted eight writers in a Travel Media Showcase pre-trip and three of the writers are top 10 influencers in travel social media. Amarillo was named the top exhibitor at Travel Media Showcase 2016 in a vote of journalists attending the show.

We are completing the fourth year of publishing the weekly email newsletter AMarillo which, thanks to forwarding by another Amarillo organization, reaches over 5,000 weekly.

Amarillo was also named a Top 10 True Western Town by True West magazine in 2016 for the second year in a row.

Communications staff received the prestigious O. Joe Russell Outstanding Club Support Award from AAF-Amarillo.

Amarillo won both a People's Choice and a Judge's Choice Award from the Texas Association of Convention & Visitor Bureaus for entries concerning the city's extensive National Tourism Week programming.

Social media is a more important section of our communications plan, and the Amarillo CVC social media presence continued to grow, reaching over 39,000 Facebook followers. Our footprint expanded to Twitter, Instagram, and Pinterest. The Amarillo CVC Madden Media campaign grossed over 36 million impressions on Facebook. This year our Madden Media focus will shift to Twitter to build and diversify our social media efforts. We think this coming fiscal year will be successful for the Amarillo CVC communications in the social platforms.

This was the second year to have the Amarillo Film Commission connected to Amarillo CVC Communications. This year we continued our membership and attended the meeting of the Texas Association of Film Commissions. Also, Amarillo joined the board of the Texas Motion Picture Alliance. The Amarillo Film Commission assisted 16 production companies with area projects.

CVC's online campaign generated close to 40 million impressions.


