Don't mean to be uncooperative but we live 140 mi from the property and are such small potatoes with only 25 acres that we don't have much to offer. Our trees and brush are too dense for a controlled burn and the land is too steep for machine access.

I do the vegetation management on our Humboldt and EI Dorado county properties and don't get permits for it. Use gas powered tools (chain saw, cycle bar brush cutter, string trimmer (weedeater). Sometimes I go with manual hedge trimmer, lopper shears and pruning saw.

Mendocino

In general, county permits are not required or authorized by the Forest Practices Act for any activity included in the definition of "timber activities" which includes far more than harvesting. For example "site preparation burning" is exempt from county regulation.
