

"Lucke Bonus Points" Promotion

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery ("Sponsor") Lucke Bonus Points Promotion ("Promotion") begins on Thursday, March 4, 2021 at 1:00 p.m. Eastern Time ("ET") and will end on Monday, March 8, 2021 at 11:59 p.m. ET ("Promotion Period"). The Promotion will include one (1) drawing on Facebook at the conclusion of the Promotion Period for a total of ten (10) winners to win the prizes as set forth below. ("Prize").

Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Winners must be a Lucke-Rewards member to redeem the Prize in this Promotion. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. FACEBOOK: Users enter with a comment on the promotion post which will be posted on Thursday, January 14, 2021 at 1:00 p.m. ET and will include the words "Comment on this post for your chance to win 1,000 Lucke-Rewards points!" (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirements made by a user on the official Facebook Promotion Post during the Promotion Period. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.
