My immediate priority is to increase the numbers of Gardaí patrolling the area and I am working closely with the local Gardaí to strengthen community policing, to improve CCTV and to progress the refurbishment of Fitzgibbon Street Garda Station. I also want to see a continuous cycle of real job offers by local employers to local people. There are good signs already through the new construction skills course with over 70% of participants now in employment so we will try and replicate this in other sectors. Together with the investment made in sports facilities and extra services for youth, there has been a programme of improvement works to roads, lighting and parks. These measures represent steps in the right direction.

I am determined that the NEIC initiative will be successful in making the North East Inner City a safe, attractive and vibrant living and working environment for all. For further information and regular updates, I invite you to visit our website www.neic.ie.

The Mulvey report titled "Dublin North East Inner City - Creating a Brighter Future, An Outline Plan for the Social and Economic Regeneration of Dublin's North East Inner City" was published in February 2017. The report recommended a number of new structures and appointments to lead this work.

In June 2017, Mr. Michael Stone was appointed by the Government to the position of Chair the NEIC Programme Implementation Board. The Board meets every month and comprises the key Government departments and agencies that have statutory responsibility for delivery of services. Building on the €5M measures implemented in 2016, the Board allocated €2.5M provided by Government in 2017 for a range of projects across the priority areas.

The Programme Implementation Board has established four working sub groups reflecting the priority areas for actions. Each group has been assigned the relevant actions from the Mulvey Report. The sub groups have representation from the community and business sectors.

The North East Inner City Programme Board and Office are working alongside a wide range of partners and organisations including community groups, businesses, employers, statutory agencies, government departments and the local authority, Dublin City Council. The Board hosted a busy and rewarding public engagement day in October 2017.

The Programme Office supports the work of the Board and is based at 51-53 Sean McDermott Street Lower, Dublin 1.

The work of the office is focusing on communications and engagement, funding and administration, assisting all sub-groups, supporting the Chair of the Board Michael Stone, sports development, local employment, community events and regularly meeting with the community.

More visible policing with an emphasis on community policing is a key feature in this project. It must be "safe" to lead and "safe" to live, work, learn and play in the community. This sub group is chaired by Chief Superintendent Seán Ward, an

- Gardai have been, and continue to be, allocated to the Division and additional personnel will be allocated to the Divisional Drugs Unit in early 2018.

CRIMEAND

- Funding of €8.5 million for the refurbishment of Fitzgibbon Street Garda Station has been approved and planning permission was lodged in December 2017. This station will be a victim and community-centred facility.
- A new Community Support Vehicle is undergoing fit out and is expected to be operational soon. The vehicle will be based in specific targeted areas on a daily basis.
- An Assertive Case Management outreach project targeting designated areas has commenced with Ana Liffey Drug Project.
- Installation of CCTV at 13 key locations has been approved and is being advanced in collaboration with Dublin City Council.
- An area specific training programme has been developed in partnership with the community, to be delivered to new Community Gardaí.
- An initiative involving Local Community groups is in development on improving relations between local youth and Gardaí.
- A seminar on drug related intimidation involving all stakeholders is being planned for 2018.
- Effective and targeted work by the Gardai on local asset profiling in tandem with the Criminal Assets Bureau is ongoing.
- The 'small areas' community policing model continues to develop in the Division.

DRUGS

#### **Project in focus:**

Assertive Case Management has been undertaken by Ana Liffey in the NEIC area with support from Dublin City Council, the Gardaí and local drug services. The clients present a range of complex issues including addictions and criminality. The goal is bring increased stability into their lives helping them access treatment services, keep Court appointments, challenge anti-social behaviour and ultimately reintegrating them back into local services. This initiative has been funded through the NEIC Programme Implementation Board.

# E D U C A T I O N, T R A I N I N G A N D E M P L O Y M E N T

Creating more linkages between education and local employers. Enhance training and employment creating more opportunities for school goers, young adults and the unemployed in the area. This sub group is chaired by Caitriona O'Brien, Department of Education and Skills.

- Five courses in construction skills targeted at long term unemployed people have been run in the North East Inner City in 2017.
- A dedicated Employment case officer has been appointed to work with individuals and employers.
- The City of Dublin Education and Training Board is recruiting two dedicated employment and career guidance workers.
- An Employers Forum will take place in February 2018 with Business in the Community to discuss skills need for the area with a view to informing training requirements and job opportunities in the area over the period ahead.
- Department of Education and Skills will facilitate a meeting of all local DEIS Primary and Post Primary school Principals in relation to the formation of a DEIS Principal's Network.
- An engagement with Post Primary schools is planned to progress improved links between school guidance; Tusla and HSCL (Home School Community Liaison) services; FET (Further Education and Training) and Higher Education access.
- Research was commissioned to help build cross-community cohesion and ensure that the NEIC initiative is fully inclusive of new communities.
- Schools have been offered assistance to find work experience for their Transition Year pupils with businesses and local employers.
- To support a number of local community services, a new Social Employment fund has been approved by the Department of Public Expenditure and Reform to assist projects experiencing difficulty in attracting people onto community schemes.
- Sports and other projects are encouraged to provide activities for young people during the summer months. The opening of schools facilities out of hours is also being pursued.
- To embed the successful Career LEAP (Local Employment Action Partnership) training programme plans to help at risk young adults find employment.

#### **Project in focus:**

Construction Skills Course: This is a three week tailored training specifically targeting the long term unemployed in the North East Inner City. This fantastic docklands initiative was hosted in Dublin Port and supported by the NEIC Programme Implementation Board and the Eastside and Docklands Local Employment Services. Over 70% of those who have successfully completed this programme have gone on to employment in the sector.

# INTEGRATED SYSTEM OF SOCIAL SERVICES

Social, educational and training services to address the real problems faced by families and their children need to be planned and delivered in a more coordinated fashion. This sub group is chaired by Conor Rowley, Department of Children and Youth Affairs.

- There has been improved coordination of outreach workers in the area and increased service coverage.
- Analysis is being carried out on the existing service provision for children, young people and families so that statutory and voluntary services work more effectively together.
- Counselling and related services for young people have been enhanced through increased funding.
- Following the appointment of a Senior Sports Officer for the North East Inner city in Dublin City Council, an audit has been carried out on sports facilities in the area.
- A 'Fit for Life' Health Awareness open day which targeted under active adults was organised for January 2018 and a 2018 Sports and Wellbeing Programme booklet was published.
- The development of a community hub at Rutland Street is being progressed with Dublin City Council.
- Support was provided to the Early Learning Initiative (ELI) in the National College of Ireland for the publication of 'Let's Talk' booklet. The initiative has also invested in restorative practice and youth leadership programmes for young people.
- Coordinated and standardised training in the areas of youth mental health for those working with children and young people has been provided for.
- A range of successful and well attended community events and festivals took place in the area in 2017 and were supported by the Programme Implementation Board including 'The Big Scream' at Halloween.
- The HSE will open a new primary care centre at Summerhill in 2018 to enhance the wide range of health services delivered in the area.



Early Learning Initiative in the National College of Ireland has been underway for 10 years. Recently, it has received support from the North East Inner City Programme Implementation Board to carry out a range of activities including a Restorative Practice session facilitated by Arthur Cox staff with young people in the area; an event to showcase the positive aspects of education in the North East Inner City; and the Let's Talk book for parents. The book will be used with 200 parents in the Home Visiting and Parent Support Groups as well as the parenting groups in the schools/services. It will be accompanied by a mirror so that the children can show parents their happy, sad, angry faces and both can develop a common language to discuss their feelings.

# PHYSICAL LANDSCAPE

This regeneration explores the potential within the area to renovate, make it liveable and bright with an improved physical landscape; to eliminate waste, derelict sites and progress the refurbishment and replacement of existing flat complexes. This sub group is chaired by Brendan Kenny, Dublin City Council.

- A number of housing development projects are being progressed by Dublin City Council including St. Mary's Mansions, Croke Villas, Poplar Row and Railway St.
- There has been large investment in on-going physical improvements including upgrade of community and sports facilities; road re-surfacing; public lighting; railway bridges.
- The Green Ribbon project, a local partnership between Dublin City Council and Sunflower Recycling will increase environmental awareness and local civic pride through small scale greening and maintenance works.
- Construction work on Phase 2 of the Royal Canal Cycleway (Sheriff St. to North Strand) progressing in 2018.
- Dublin City Council is actively pursuing property and landowners to improve derelict or unsightly commercial and housing sites in the area.
- Dublin City Council is piloting a Shop Front Improvement Scheme with shop owners in Dorset St.
- The North Inner City Folklore Project has been re-located to Unit 1, The Forge, Railway St. and is being supported as it develops a sustainable plan for the future.
- New community events have been delivered including The Big Scream Halloween Festival, The Last Picnic and several existing local events supported e.g. The Five Lamps Arts Festival, Monto Picnic, and Christmas events at HOPE and Larkin Community College.
- The NEIC Greening Strategy has commenced, preliminary analysis has been completed and workshops will be held to give local communities an opportunity to input.
- Dublin City Council has commenced work on a Public Realm Plan for the local area, this will be a planning document to set out a long-term vision for the local built environment.

#### **Project in focus:**

Refurbishment of Mary's Mansions: In December 2017, Clúid Housing began a €21m redevelopment of St. Mary's Mansions flat complex. The regeneration works will provide high quality social housing to 80 local families and single people. Building on the strong sense of community spirit in the area, the redesign of St. Mary's Mansions focused on the input of existing and new residents and a number of key features were specifically included to enhance overall quality of life. These include communal social and play areas, a community room and socially aware landscaping. At the heart of the regenerated St. Mary's Mansions will be a central courtyard designed to support community activities. The partnership project is being delivered between a number of organisations.

# FUNDING

As the focus of the work of the Programme Implementation Board has been to take an innovative and radical approach to stimulate change, spending money is not the only measure of progress. However, there has been significant investment from the Government in the North East Inner City.

The following section details funding allocated via the NEIC Programme Office to NEIC initiatives since the announcement of the North East Inner City Initiative by the former Taoiseach in July 2016.

The 2016 funding for delivery of short term measures, pending publication of the Mulvey Report was managed by the Dublin City Council NEIC Project Office and a number of government departments directly. This was prior to the appointment of the Chairman, and establishment of the Programme Implementation Board in July 2017.

The following summary table sets out the sources and amounts of funding which had been provided in 2016 and 2017. Further detail on individual projects and the current status of each project is provided in the Appendices towards the end of this report.

Government is funding the initiative under the Department of Rural and Community Development's RAPID subhead for 2018 on the same basis as 2017. This will provide €2.5 million, mixture of capital and current funding, to be allocated by the NEIC Board in 2018

In addition, funding has also been provided in 2018 under the direction of the NEIC Board to support the development of a pilot social employment scheme, details of which are currently being advanced.

# AMBITION FOR 2018

### The Programme Implementation Board and all those involved in the regeneration of the North East Inner City have had a busy first six months.

The work of the Programme Implementation Board for 2018 will continue to be driven by the actions and ambition in the Mulvey Report "Creating a Brighter Future". Both the Board and Programme Office staff will work hand-in-hand with the local community and maintain strong relationships with local projects, employers and public representatives. The Board wants to see increased visibility of community policing in the area supported by further extension of CCTV coverage and the refurbishment work of Fitzgibbon Street Garda Station to get underway.

While there has been a very positive start achieved since June 2017, with solid structures and initial funding measures put in place, the focus now shifts to tackling the fundamental changes required to transform the area over the long-term. The Board will push for greater ambition for the current and future generations of young people growing up in the area. Both in and out of schools, this will require a tailored career guidance for young people, coordinated with opportunities for work experience in local businesses, creating improved pathways for third level programmes, apprenticeships and local employment training provision and real jobs. Employers in the area will be encouraged to continue to link their corporate social responsibility to specific local schools and projects.

Building on the success of the construction skills course, the Board intends to support the development of training in other fields reflecting the skills local employers have highlighted. Efforts will continue with employers in the area to increase the flow of local job offers. In order to meet the immediate needs of local services, a new pilot Social Employment Scheme will be put in place as will further supports to enhance strategic planning capacity among local projects.

The Board recognises the need for an in-depth look at how local services are aligned and delivered to ensure that they are fully responsive to the needs of the area. Any new investment must support the development of sustainable services to meet identified needs and must also be used to unlock opportunities for greater collaboration, co-operation and synergies across existing funded services and providers. This review will be carried out in cooperation with community and statutory services.

The Board will also give some consideration in 2018 as to how best to measure the impact of the overall initiative. This would not only take into account existing measures such as area statistics and surveys for population, employment, education, crime and litter but also seek to reflect the attitudes and views of local residents as the work progresses.

Finally, work is underway to engage and support the involvement of new communities in the North East Inner City initiative as well as specific measures aimed at the community of older people in the area. The programme of physical improvement works will continue and a programme of festivals and events will be delivered which aims to involve all members of the community. The range of physical improvements for the area will continue informed by a new Public Realm Plan and Greening Strategy developed for the North East Inner City.
