

**“We Live In Time” Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN.

“We Live In Time” Sweepstakes ("Sweepstakes") starts at 4pm ET on Saturday, October 5, 2024 and ends at 4pm ET on Sunday, October 6, 2024 ("Sweepstakes Period").

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and District of Columbia, who are 18 years of age or older. Employees of A24 Films LLC ("Sponsor"), its parent, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state and local laws. By participating, each entrant agrees to abide by these Official Rules and decisions of Sponsor and judges, which shall be final and binding in all respects relating to this Sweepstakes.

Please be sure to have permission from your date to post the video or photo in connection with entering the Sweepstakes. All entries must be received by Sunday, October 6, 2024 at 4pm ET. Entries generated by script, macro or other automated means or by any means which subvert the entry process, including but not limited to, the use of multiple accounts, are void. Limit one (1) Entry per person for the entire Sweepstakes Period, regardless of method or platform of entry. Multiple Entries from any person will be void. If you do not have a TikTok, Instagram or X account, establishing an account is free. All TikTok, Instagram and/or X terms apply, as applicable. Your TikTok, Instagram or X account must be set to “public” in order for your entry to be eligible. You can return the account to “private” any time after the winner has been announced. - contains look-alikes of celebrities or other public or private figures, living or dead;
- communicates messages or images inconsistent with the positive images and/or good will to which we wish to associate; and/or
- violates any law.

Sponsor may disqualify any Entry for any reason, including if it determines, in its sole discretion, that the Entry fails to conform to these Official Rules in any way or otherwise contains unacceptable content.
