Agenda No. 03:- Review of final year student's results for the academic years 2017-18.

The Chairperson of the Examination Committee Mrs. Supriya Salvee presented the details of the result of the examination held from March to June for the academic year 2017-18. The copy of the said information was issued to all members. After going through the result, the Cell observed that the performance of the students of BMS and M.Com programmes is exCellent (more than 94%) and in case of BCBI it was 87.87%. The Cell directed the Departmental Head of Commerce to take appropriate steps to enhance the result of TYBCOM class to a higher level in the coming years.
