## How and When to File for Extended Unemployment Benefits

**IMPORTANT**: If you file before you have exhausted benefits, or before you show a balance of zero, it will cause a delay and create issues for your claim. Please do not file for an extension until your balance shows zero.

When your claims benefit balance shows zero, please file a claim to set up the PEUC or EB extension. To be eligible for an extension, you must have an eligible Tennessee unemployment claim with a Benefit Year End (BYE) of 07/01/2019 or greater and not qualify for a standard Tennessee Unemployment Compensation or compensation in another state.

To get to the screen below, go to Services for individuals, Unemployment Services, Claim summary, and scroll down. Once you reach a zero balance, please file for an extension.



To file for an extension, go to "Services for Individuals", then "Unemployment Services", and then "File a Claim".

You will receive the message below. Click "Next" to start the filing process.

## **Explanation of Extension Program Benefits**

- **PEUC** (Pandemic Emergency Unemployment Compensation) is an additional 13 weeks of benefits, and EB is half of your TUC Maximum Benefit Amount.
- **TUC** (Tennessee Unemployment Compensation) must be drawn out to zero before PEUC can be established.
- PEUC must be drawn out to zero before **EB** (Extended Benefits) are established.
- If eligibility is found for any standard unemployment claim, you must draw from that claim before receiving any extensions.
