COMPLAINT / INFORMATION

COMES NOW the State of Kansas, by and through Derek Schmidt, Attorney General, and Jessica G. Domme, Assistant Attorney General, for its Complaint/Information against the Defendant above-named, alleges and states:

COUNT 1

ATTEMPTED CAPITAL MURDER

Off-Grid Person Felony

That on or about the 30th day of August, 2020, in Saline County, and State of Kansas, **ADAM DREW HUMPHREY** did, then and there, unlawfully, feloniously, and intentionally commit an overt act, to-wit: **discharged a firearm at Salina Police Department Officer Cody Way**, toward the perpetration of the crime of capital murder, which is the intentional and premeditated killing of a law enforcement officer, but failed in the perpetration thereof, contrary to and in violation of K.S.A. 2019 Supp. 21-5401(a)(5), and amendments thereto, and K.S.A. 2019 Supp. 21-5301(a), and amendments thereto; penalty section: K.S.A. 2019 Supp. 21-5401(c), and amendments thereto.

COUNT 2

ATTEMPTED CAPITAL MURDER

Off-Grid Person Felony

That on or about the 30th day of August, 2020, in Saline County, and State of Kansas, **ADAM DREW HUMPHREY** did, then and there, unlawfully, feloniously, and intentionally commit an overt act, to-wit: **discharged a firearm at Salina Police Department Officer Jesse Christmas**, toward the perpetration of the crime of capital murder, which is the intentional and premeditated killing of a law enforcement officer, but failed in the perpetration thereof, contrary to and in violation of K.S.A. 2019 Supp. 21-5401(a)(5), and amendments thereto, and K.S.A. 2019 Supp. 21-5301(a), and amendments thereto; penalty section: K.S.A. 2019 Supp. 21-5401(c), and amendments thereto.

COUNT 3

AGGRAVATED ASSAULT OF A LAW ENFORCEMENT OFFICER

Severity Level 6 Person Felony

That on or about the 30th day of August, 2020, in Saline County, and State of Kansas, **ADAM DREW HUMPHREY** did, unlawfully, feloniously, and knowingly place a law enforcement officer, to-wit: **Saline Co. Sheriff's Deputy Joel Shaffett**, in reasonable apprehension of immediate bodily harm, with a deadly weapon, to-wit: firearm, contrary to and in violation of K.S.A. 2019 Supp. 21-5412(d)(1), and amendments thereto; penalty section K.S.A. 2019 Supp. 21-5412(e)(4), and amendments thereto.

COUNT 4

CRIMINAL POSSESSION OF A FIREARM BY CONVICTED FELON

Severity Level 8 Nonperson Felony

That on or about the 30th day of August, 2020, in Saline County, and State of Kansas, **ADAM DREW HUMPHREY** did, unlawfully and knowingly possess a firearm, and within ten years preceding such possession has been convicted of a felony, to-wit: **aggravated assault, Sedgwick Co. District Court Case No. 14CR971**, and was not found to have been in possession of a firearm at the time of the prior crime, and has not

had the prior conviction expunged or been pardoned for such crime, in violation of K.S.A. 2019 Supp. 21-6304(a)(3)(A), and amendments thereto; penalty section: K.S.A. 2019 Supp. 21-6304(b), and amendments thereto.

All of the said acts then and there committed being contrary to the statutes in such cases made and provided and being against the peace and dignity of the State of Kansas.


