AFFILIATE AGREEMENT

Welcome! To promote Foxbrim Naturals products, your ClickBank account must be whitelisted by us. You should be receiving an email shortly approving your request. Please read the following terms & conditions that you must agree to in order to promote our products. Also on this page you will find our top performing emails to help you to be successful.

Terms & Conditions

This agreement describes the entire terms and conditions for participation in the Foxbrim Naturals Affiliate Program.

In this agreement, the term "Affiliate" refers to you (the applicant/affiliate). Wherever the agreement refers to "you" or "your", it means "the Affiliate"; "we" or "our" refers to Foxbrim Naturals.

ClickBank Sign-up

The Foxbrim Naturals affiliate program is administered by Clickbank.com. You must be a Clickbank Affiliate in order to be credited for commissions earned through referral sales of this program. Please make sure that you have read and understood the policy, terms and conditions of the ClickBank affiliate program.

Affiliate Site

ClickBank will create a unique nickname for you when you submit a complete ClickBank Affiliate Enrollment Form. You do not need to have a website to be an affiliate; you may use your affiliate URL in email promotions to potential customers.

Commissions

You will receive 60% of the revenue as a commission from the initial order placed through your unique Affiliate URL link, less the charges outlined by ClickBank in their agreement http://www.clickbank.com/paychecks.html. It is 20% on renewals. For a sale to generate a commission to an Affiliate, the customer must complete the order form and remit full payment for the product ordered. Commissions will only be paid on sales which are made through qualified Affiliate links.

Payment

ClickBank will send a check for the applicable commissions within the framework of their policies http://www.clickbank.com/paychecks.html. If any order that generated a referral fee is returned by the customer, or if there are any returned checks or chargebacks, the amount will be deducted by ClickBank from the next payment due affiliate.

Promotional Policies And Guidelines

Before promoting, please be aware of the following regulations:

- 1. **Affiliates are NOT** permitted to use ANY Foxbrim before/after photos in their promotions without written permission from Foxbrim.
- 2. **Affiliates can NOT** run ads for any advertising, including but not limited to, Google (or any Google property), Facebook, Bing, Instagram, Pinterest nor bid on "Foxbrim" branded keywords, or use the term "Foxbrim" in any ads
- 3. **Affiliates are not** permitted to use any terminology in ads or landing pages that are similar to "scam" or "fraud".
- 4. **Affiliates must NEVER** use any images or videos that they do not explicitly own, and are forbidden from using any imagery that would imply any endorsement without written consent from the appropriate parties.
- 5. Affiliates are forbidden from creating webpages, social media pages or accounts that falsely represent themselves as the creators or owners of Foxbrim products. - 8. Foxbrim Naturals will be solely responsible for all customer service inquiries.

Any affiliate caught breaking any of these terms will be banned immediately without hesitation, and will not be eligible for reinstatement.

Qualifying Sites

Foxbrim Naturals reserves the right not to accept any site into the Affiliate Program based on site content. Sites that Do Not Qualify for the Foxbrim Naturals Affiliate Program include sites that:

- promote sexually explicit materials
- promote violence
- promote discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age
- promote illegal activities
- violate intellectual property rights
- send Unsolicited Commercial Email or SPAM
- use misleading advertising

Discovery of such sites promoting the Foxbrim Naturals products will be terminated immediately. Foxbrim Naturals in no way participates in mass unsolicited emailing (i.e. spamming), spyware or adware, and all Affiliates are expected to adhere to this policy. Violation of this policy will result in the termination of this contract and immediate dismissal from the Foxbrim Naturals Affiliate Program, with no refund.
