Description: Senator Michael Webber (R) of Rochester Hills has been a legislative champion for children with serious emotional disturbance and their families who have experienced difficulties accessing services from the community mental health services providers (CMHSPS) in Michigan. He has also been instrumental in seeking to improve psychiatric treatment in Michigan's state and private psychiatric hospitals. Senator Webber will discuss the audit of the rights offices he requested in 2023 and the results received from the Auditor General in September of this year. He has been working with families who have children in state and community-based psychiatric hospitals and units and will speak on his work and efforts to improve the continuum of care for children and adolescents who require inpatient and/or residential psychiatric treatment.
