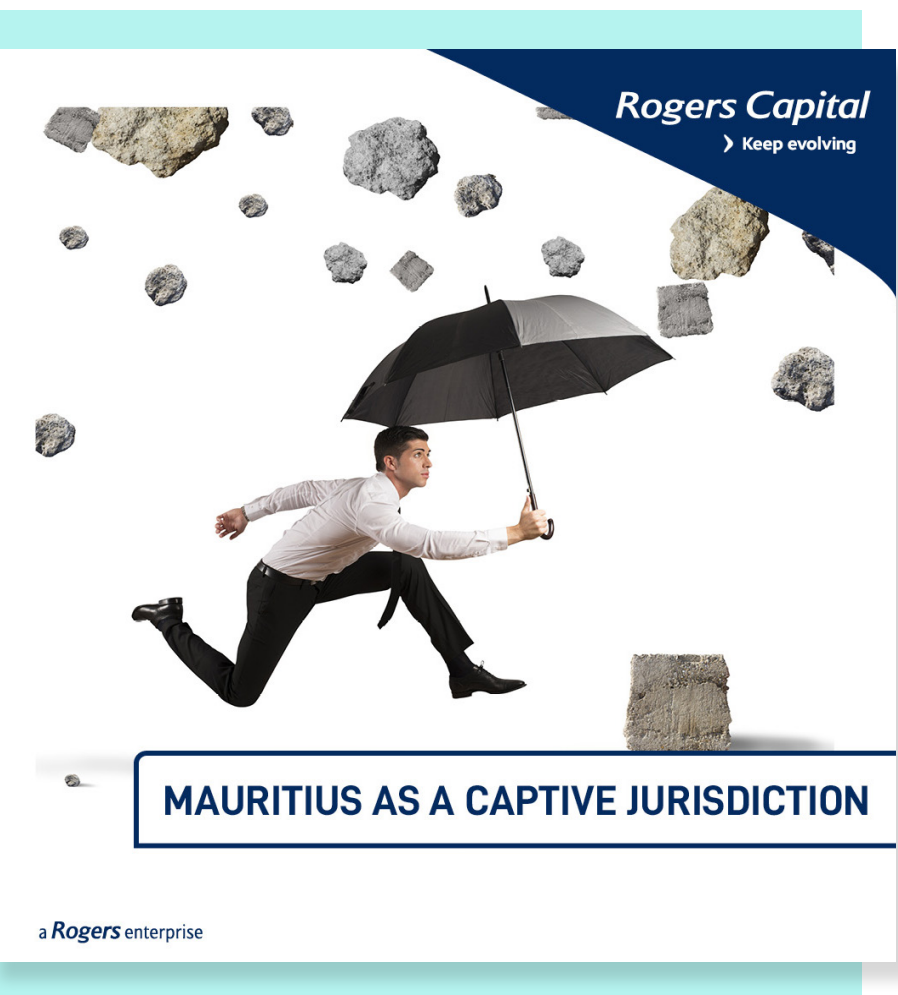

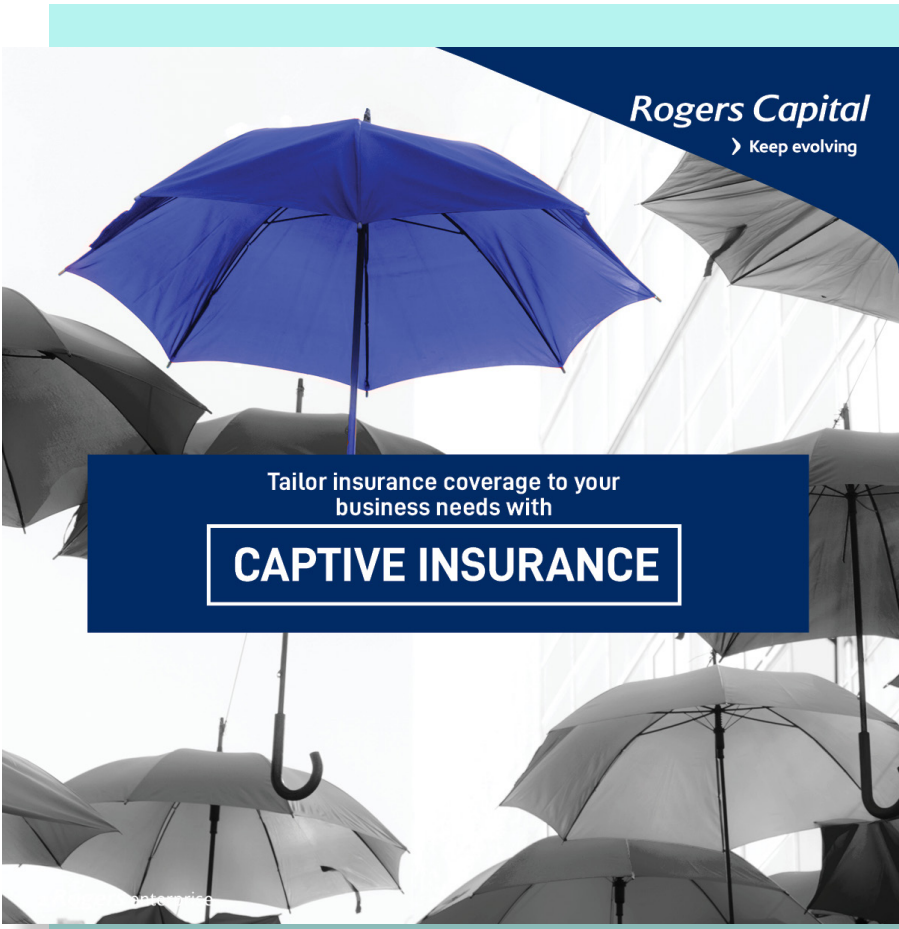


01 MAURITIUS AS A CAPTIVE JURISDICTION
