## **PACKAGING WASTE - IMPLEMENTATION**

- Municipal responsibility for municipal waste management
- Municipal waste: household and similar commercial and industrial
- Commercial and Industrial packaging (included in PPWD)
- Example of EPR: FostPlus and VALIPAK, Belgium
- Clear Roles and Responsibilities, Continuity and Dependability



## EPR

- Any Extended Producer Responsibility system must set clear Roles and Responsibilities for the:
  - Producers
  - EPR organisation
  - Municipalities
- This is a National obligation also to bring the parties responsable together once per year to discuss any issues that come up on implementation
- Model contract between EPR and Municipalities agreed between the two entities and signed with each municipality



## EPR

- Minimum 80% cost coverage to municipalities to assist convenient collection system, quantity and quality
- Benefits EPR and Producer
- Circular Economy Benefits
- Caution on Waste Shipments unregistered traders
- SUP: included in 80% cost coverage, including waste bins on streets (litter bins)
- Continuous communication to citizens



## **PPWD – STATE OF PLAY**

- The Commission has done many impact assessment studies to decide what to put in the annexes of the legislative text.
- Information meeting next week. KIGO very important partner for MWE - will receive an update from us directly after the Commission meeting
- From Directive to Regulation what does that mean?



#### **Background and Timeline:**

- European Green Deal
- Circular Economy
  - From a linear to a circular economy there is a need to link up waste materials with production hence a need to recover them from the waste stream
  - Increased coordination EPR
  - Increase Quantity and Quality
  - JRC working on harmonisation since 2021
- Revised Waste Framework Directive 2024



- The JRC is exploring all options for harmonisation of separate collection:
  - Bin colours
  - Labelling
  - Economic instruments (PAYT, DRS, etc.)
  - Frequency of collection
  - Comingling of several waste streams



- Local adaptation is the key to success
- MWE believes harmonisation of bin colours at EU level would be counterproductive:
  - 1. High financial cost of replacing all bins in Europe
  - 2. Wasteful in terms of materials
  - 3. Inflexible Cannot be adapted to local sorting plant

MWE supports a voluntary labelling system based on the Nordic Pictogram System



## **NORDIC PICTOGRAM SYSTEM**

- The system was first developed in 2016 in Denmark.
- Aims to make waste sorting easier for citizens.
- Collaboration between Local Government Denmark, Danish Waste Association, and the Environmental Protection Agency
- The key purpose = the same waste sorting communication whenever and wherever disposing of waste in Denmark.
- 89 pictograms for household waste and waste collected at recycling stations
- The symbols can be applied for household waste and at recycling stations.
- In 2020, 91 Danish municipalities (out of 98) have implemented the system.
- In 2020, both Norway, Iceland and Sweden launched the system in the three countries. Finland is on its way











# Extended Producer Responsibility (EPR) for Packaging

- A separate collection system can only be truly successful if it is fully coordinated with the local EPR system which pays municipalities at least 80% of their cost for the collection and treatment of packaging
- The Belgian example is often taken as a good model to copy as their EPR organization for packaging has a direct relationship with each municipality and a contract with each one with the agreement on collection and payment
