Though supporting documentation is encouraged, the total number of pages such documentation can add to a submission is five. Any submission exceeding thirteen pages will be returned to the submitter, who, if the submission deadline has not passed, may elect to resubmit it, accordingly. A panel of judges will evaluate the responses received in order to determine which company (companies) best met the award criteria. Additional information may be requested by any judge from the submitter in order to verify or clarify any of the information contained in a response or in the supporting documents (**noting that any supporting documentation submitted will be used for illustrative purposes only and will not be used to judge the submission**).*

### **Institutionalization**

Describe the Culture of Safety model or system used by the organization which has enabled it to achieve its noteworthy success. Describe the investment in time, people, money, equipment (if applicable), or other resources that is directly responsible for the success. Identify the person, process or implementation technique used to immerse the organization into a culture of safety.

### **Achievement**

Describe how the entry is a significant safety achievement, rather than simply recognition of a company “doing its job.” Describe in detail, by one or more examples, how your “Culture of Safety” model or system has **prevented injury**.

### **Documentation**

Provide data **for at least the past five years** to support the organization’s outstanding safety performance. The documentation submitted should be a summary of acceptable interpretative standards such as **EHS Performance and TRIR statistics, OSHA reports, near-miss data, stop work actions, etc.** Companies, programs, or initiatives newer than five years old are still eligible to participate. Please note on the application that five years of data collection is not yet available and include as many years of data that is available.

### **Industry Adaptability**

The company’s (companies) culture of safety should be an inspiration or example for the entire industry. Please explain the steps taken or elements of this model that could be **adopted** by other companies or could otherwise be **useful** to a wide segment of the industry.
