**PRESCRIBED BURN IN HORSE ARENA AREA IN BIDWELL PARK  
SCHEDULED FOR FRIDAY, DECEMBER 6, 2024**

**CHICO, CA, - December 4, 2024** - The City of Chico Park Division and Fire Department, in partnership with the Butte County Resource Conservation District, Prescribed Burn Association, Big Chico Creek Ecological Reserve, Mechoopda Tribe, Deer Creek Resources, and Butte County Cal-TREX, have scheduled a prescribed pile burn in Middle Bidwell Park on **Friday December 6, 2024**. The pile burning will begin at approximately 10:00 a.m. and will last until Saturday morning. However, this burn will depend on the right temperature, wind, and other weather conditions on Friday.

The intent of the prescribed pile burn is to reduce downed and dead woody material in the Oak woodland area between Horse Arena Way and the Sycamore Channel levy fence. The Horse Arena area has been identified as a critical area in the City of Chico Wildfire Protection Plan, so the burn will help enhance public safety and mitigate the risk and impacts of wildfire.

To prepare for the burn, crews will be working in the area on Thursday December 5<sup>th</sup> to cut the larger woody material into more manageable sizes so that it can be placed into 6 to 8 burn piles in open areas away from the understory of trees.

For the public's safety, trails between Horse Arena Way and the Sycamore Channel levy will be closed to all users. Signs will be placed at these trailheads. A Ranger will be at the main gate and monitors will be placed at other locations to help inform park users of the burn.

Access to the Horse Arena facilities and trails to west of Horse Arena Way will be allowed, but equestrians and the public are asked to be cognizant of the saw work and burning operations. The Parks Division and Fire Department are also asking for the public's cooperation by avoiding this area until after the burn if possible and in complying with the trail closures.

A Burn Plan, Burn Permit, and Smoke Management Plan have been approved by Chico Fire and the Butte County Air Quality Management District for this prescribed burn.

Butte County Cal-TREX provides a peer-to-peer learning experience where both fire professionals and ordinary citizens gain prescribed fire skills through hands-on field scenarios and training to strengthen local capabilities, including enhancing the City Parks Department's capacity to conduct prescribed burns to enhance community safety.
