

## **Sephora Digital Events Survey Sweepstakes**

### **NO PURCHASE NECESSARY TO ENTER OR WIN.**

**ELIGIBILITY:** OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND DISTRICT OF COLUMBIA, 18 YEARS OF AGE OR OLDER, WHO ARE THE DIRECT AND INTENDED RECIPIENTS OF A SURVEY INVITATION. VOID WHERE PROHIBITED. Employees, officers, directors and agents of Sephora USA, Inc.
