1. Purpose of report:

To consider representations that have been made in respect of an application for a Premises Licence which seeks to permit the Sale of Alcohol (for consumption off the premises only) to operate from 24hours (Monday to Sunday).

Due to the nature of the application the public will not have access to the premises.

2. Recommendation:

3. Brief Summary of Report:

An application for a Premises Licence was received on 21st July 2021 in respect of 6 & 7 Chad Square, 43 Hawthorne Road, Edgbaston, Birmingham, B15 3TQ.

5. Relevant background/chronology of key events:

Quick Commerce Ltd applied on 21st July 2021 for the grant of a Premises Licence for 6 & 7 Chad Square, 43 Hawthorne Road, Edgbaston, Birmingham, B15 3TQ.

Representations have been received from other persons, which are attached at Appendices 1 to 8.

The application is attached at Appendix 9.

Conditions have been agreed with West Midlands Police and the applicant, which are attached at Appendix 10.

Site Location Plans at Appendix 11.

When carrying out its licensing functions, a licensing authority must have regard to Birmingham City Council's Statement of Licensing Policy and the Guidance issued by the Secretary of State under s182 of the Licensing Act 2003. I wish to object to the application on this list for what appears to be a "dark kitchen" at Units 6 & 7 Chad Square Edgbaston. I represent Edgbaston Ward and this is also my own local shopping centre with my local newsagent as I live on Harborne Rd.

I am very concerned that such an operation will result in a number of delivery drivers taking up the limited car parking spaces in the private shoppers' car park and maybe causing mayhem on the neighbouring roads of the estate which are all private roads owned by Calthorpe Estates and are not the public highway. I do not think therefore there will be adequate space for the delivery drivers this operation will attract, and question whether a small local shopping centre is the correct location for such an operation.

Further there is likely to be noise nuisance and coming and going from what is going to be a 24 hour operation and there are flats above these shops, as well as other flats and houses very close by so the potential for noise disturbance through the night is great.

What actions are you taking to ensure there are correct extractor fans because the nuisance of 24 hour cooking smells again could be very objectional to the residents who live above these shops. I don't know if such a change of use requires Planning permission and I am asking Planning about this, but please note my very strong objection to this application as I think it is an unsuitable business to open in a small local shopping centre, with limited car parking, and residential units above it.

I wish to object to the application in connection with premises at Units 6 & 7Chad Square, Edgbaston, Birmingham, B15 3TQ.

I live opposite the proposed site and we would have to bear the full brunt of a 24 hour business and traffic, which is not in keeping with a residential area.

This a residential area with a small limited retail area on the square and very limited parking. The proposed use of these units is not suitable for this area, as much as we would like to see the space used.

24 hour use would considerably increase the noise, nuisance and air pollution out of all proportion for a residential area.

The increased volume of traffic would be completely disproportionate with the area which already has parking problems for residents with the extra traffic wishing to park following the start of the Clean Air Zone.

There is also the safety issue to be considered in addition to the health issues. Pedestrians cross the car park regularly. Also many children cross this area on their way to and from the many schools in this area, and they do not take into account that traffic uses the car park as it is, and this would, therefore, increase the possibility of more accidents taking place. There have been several near misses in the past, and this would increase if the proposed use of these premises is granted.

I understand there is a general Licensing Notification in the system for what is basically I think a "Dark Kitchen" at Units 6/7 Chad Square, B15. These are the former newsagents and men's outfitters, and are directly opposite my Flat at Malmesbury Park on Hawthorne Road B15.

I have been informed that the following issues with "Dark Kitchens" have arisen in other parts of the city:

- 1. Lots of Deliveroo type delivery drivers waiting around for deliveries, taking up all the car park spaces in the shoppers' car park and lining neighbouring streets. Also noise nuisance from the waiting drivers/bike riders.
- 2. Continuous cooking smells if there are not adequate extractor fans

As I am semi-retired I spend a lot of time in my study which looks out over the Square and am not at all happy about having what is essentially a busy light industrial unit staring me in the face at all hours of the day and evening.

Please take this email as a very strong objection to this application from an affected local resident. I urge the Council to respect the quiet residential nature of this whole development (which is why most of us have chosen to live here).

Dear Sirs

Having been provided with information relating to the above application, I wish to lodge an objection on the following grounds:

The unit/s in question are located within a small, peaceful residential shopping parade serving the surrounding residents in what is, essentially, a very quiet residential area, particularly in the evening.

The junction from Hawthorne Road (opposite the White Swan) can be difficult to pull out of in busy times due to the speed of the traffic and poor visibility from the bend in the road (coming away from Harborne) and a considerable increase in traffic using this junction will only exacerbate the issue, leading to potentially more accidents. The junction nearby with Richmond Hill Road is also busy and there are several accidents or near misses in this area fairly regularly, notwithstanding the fairly regular flow of ambulances from the QEHB that use this route. Highways should certainly be consulted in respect of the huge increase in traffic the proposed scheme would attract.

Has there been any consideration/survey in respect of the local wildlife population? There are notably many varieties of wildlife on this estate, including bats and owls that can be heard in the quiet of the night by the shops and in the locality. Any use that increases night-time activity can only serve to deter the nocturnal wildlife in an area which should be celebrated (and encouraged) in the city.

I live in the flats opposite with two young boys. Night time disturbances are thankfully very rare at present (perhaps the odd late night taxi drop off) but continued night time disturbance would be incredibly detrimental — not only to our quality of life, but to all other residents in the locality. It does seem incomprehensible to me that a unit such as this would be considered for this type of operation, with residential flats above and in close proximity, the increased traffic, pollution, noise and general disturbance that a unit of this nature will inevitably attract. There are a great many empty light industrial locations in reasonable proximity that would be far more suited to this type of operation.

Please do consider the consequences of this application carefully as it could easily destroy what is a peaceful, family orientated residential area.

I am writing to object to this licensing application in Chad Square.

This is a quiet residential area, consisting mostly of retirees, unsuitable as a location for a commercial cooking/delivery enterprise. Besides the obvious concerns over congestion and noise at all hours from multitudes of motor bikes servicing this business, consideration must be given to the dangerous character of the adjoining road junction of Hawthorne Road, Harborne Road and Richmond Hill Road. I live right next to this junction and not a week passes without an accident/traffic collision occurring here, most of which go unreported as fortunately they mostly occur between two cars with the incidence of personal injury being low. However, should such inevitable accidents occur between motor bikes/scooters/mopeds prevalent in this type of enterprise and cars/buses, personal injuries, possibly fatalities, are inevitable. It would be negligent to locate a delivery business in this particular location, they are more suited to an industrial estate.


