

**Queenpins Golden Coupon Sweepstakes**  
**OFFICIAL RULES**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. INTERNET CONNECTION REQUIRED. VOID WHERE PROHIBITED BY LAW.**

**PROMOTION DESCRIPTION:** The Queenpins Golden Coupon Sweepstakes (“**Sweepstakes**”) starts on or around September 9, 2021 at 12 a.m. Pacific Time (“**PT**”), and ends at 11:59 p.m. PT on September 29, 2021 (“**Promotion Period**”). Beginning on September 10, 2021 and through September 30, 2021 (the “**Drawing Period**”), a random drawing will be conducted daily from among all eligible entries received during the Promotion Period to select twenty (21) total Grand Prize winners, limited to one (1) Grand Prize winner per day during the Drawing Period, as more fully set forth below. Sponsor’s computer is the official clock for this Sweepstakes. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. The sponsor of this Sweepstakes is STX Productions, LLC, 3900 West Alameda Ave., 32<sup>nd</sup> Floor, Burbank, CA 91505 (the “**Sponsor**”). Twitter Inc. (“**Twitter**”), and Instagram, LLC (“**Instagram**”, and collectively with Twitter, the “**Social Platforms**”) are not sponsors of this Sweepstakes and do not endorse or otherwise have anything to do with this Sweepstakes. Entrants are providing information to Sponsor and not to the Social Platforms. The Sweepstakes shall be subject to these “Official Rules,” and by entering, all participants agree to be bound by the terms and conditions herein.

Note: Entrants must add #QueenpinsSweeps to the Entry on Social Platforms in order for the Sponsor to be able to view the entry and contact the potential winners.

By completing the foregoing during the Promotion Period, you will be entered into the Sweepstakes and each individual submitting such Entry shall be an "**Entrant.**" **ALL ENTRIES MUST BE RECEIVED BY 11:59 P.M. PT ON September 29, 2021.** For purposes of clarification "**Entry**" includes the tweet uploaded and submitted to the Sweepstakes.
