ABOUT FQ CCD

What Is the FQ Community Club Development (CCD) Initiative?

The FQ Community Club Development (CCD) initiative is designed to provide community football coaches and administrators with a simple and clear club development plan. Successful community clubs will work from a central development plan that is supported by FQ Club Development Ambassadors.

Within the FQ CCD there is a full Discovery and Skill Acquisition Phase coaching resource designed to provide ongoing assistance to further develop community clubs, players and coaches in Queensland.

The CCD will play a significant role in fostering positive experiences for all members within the game.

THE PROCESS & SERVICE

Which clubs are eligible and how do clubs gain access to the FQ Community Club Development plan?

Any community (non-NPL) club affiliated with FQ can become part of the FQ CCD. To begin the process, club administrators will have to apply through an CCD EOI (Expression of Interest) form. Please visit the CCD webpage to register: footballqueensland.com.au/ccd

What does FQ provide to clubs within CCD?

To help create positive learning environments, each club will have access to free community coaching collateral including training cycles and session plans. This will ensure clubs have the tools to deliver quality Discovery and Skill Acquisition Phase training sessions which nurture key technical skills in their players.

Club Administrators will be provided with support resources within the Club Support Hub. The Hub provides a destination for club-related resources, information and guidance for volunteers.

Club Coach Coordinators will also receive regular updates at workshops.

FEES

Are there any fees or charges for clubs?

No. The CCD initiative is completely free for clubs to join. All collateral will be made available once the setup process is complete.

REQUIREMENTS

What must clubs deliver to gain FQ CCD accreditation?

For community clubs to obtain the CCD resources, they must (non-negotiable):

- Have a Club Coach Coordinator (CCC) in place at the club or equivalent for example technical director or coaching coordinator.
 - CCC will be required to attend at least one coaching workshop during the calendar year
 - CCC will be required to provide an end of season report to the club, available for FQ to view

CCD clubs must support the following best practices:

- Register all coaches in the PlayFootball registration system within a club coaching package
- Register all players in the PlayFootball registration system within appropriate packages
- Have a Blue Card Club Procedure in place managed by a Blue Card Club Manager details on these requirements will be outlined in the Working with Children Club Guide available soon via the FQ Club Support Hub
- Not place extra cost to participants and players as a result of receiving the free CCD Resources

Other FQ recommendations:

- Ensure all coaches attend a MiniRoos or Skill Training coaching course
- Deliver a MiniRoos Kick-Off program
- Run a walking football program
- Host a Girls United program
