The introduction of the Building Safety Act and the new Gateway 2 requirements were discussed at length during the day, and it is clear that there remains significant uncertainty over these requirements. In particular, what level of detail is needed as part of the Gateway 2 submission? We are keen to hear your experiences (both good and bad) of this. #### **CWCT Courses**

Our programme of short courses is nearly complete for this year. In total we had over 600 people signed up to the 10 courses that we offered, which is fantastic.

Following the introduction of the Building Safety Act, competence is a key industry challenge. We believe that our courses are an important part of the evidence required to meet competence requirements.

In response to this, we introduced assessment following each course, which must be successfully completed to receive a CPD certificate.


Finally, we are in the process of completely updating our 'Managing the cladding package' course, following feedback from Members. The review is being undertaken with key stakeholders involved in the design and execution of façades.

#### **CWCT Technical Notes**

We are pleased to announce the publication of two new Technical Notes, that form part of a new series on fire. These are:

- TN113 An introduction to fire and facades,
- TN114 Use of combustible material,

These documents are free to download for CWCT Members via the Cladding Forum.

We continue to work on the two remaining Technical Notes in this series:

- Application to curtain walls,
- Application to built-up walls.

Following the publication of the latest Technical Notes in our thermal series, we organised a webinar to promote the guidance. We were really pleased with this webinar. Over 100 people attended, and we had some interesting questions and discussion following












the presentation. Due to the success of this, we plan more in the future.




Our recent webinar to introduce of thermal Technical

With the support of the Technical Committee, we continue to work on other draft Technical Notes, on subjects including breather membranes and vapour control layers, interfaces and brick slip systems.

# **Sustainability**

We continue to lead the way with our work on façade sustainability. We have recently recruited a new Senior Engineer to lead this work, which we are very excited about.

Wider adoption of façade embodied carbon calculation remains a key focus. Assessments are complex and this presents a potential barrier to their widespread adoption. One way to try and improve this situation is to provide an assessment tool to CWCT Members. WSP have very kindly offered us the opportunity to make their embodied carbon tool available to the Membership, and we are very grateful to WSP for providing this. We hope to launch this soon.

We are looking at various other options to further support this, including offering training.

Separately, we have begun a minor update to the embodied carbon methodology following the publication of revised RICS guidance.

Two further short documents in our sustainability series will be published soon. These are looking at façade complexity, and the importance of recognising this during early-stage calculations, and module D.

All of our sustainability documents, including the methodology are free to download for CWCT Members via the Cladding Forum.

Our other <u>sustainability workstreams</u> are all progressing well. This includes our work on EPD's which will be published very soon.

Finally, a reminder about our <u>Sustainability Stories</u> platform. Again, this is an area where we need your help. Please consider submitting your own Story – this is an opportunity to highlight the fantastic work that we know many of you are doing in this area.

# Health and safety in facades

As previously reported, guidance on H&S issues related to façade design is live on our <u>website</u>.

We have been disappointed with the lack of response on this initiative. This is something we would like to develop further, so if you have suggestions for topics that you think should be included, please email <a href="mailto:cwct@cwct.co.uk">cwct@cwct.co.uk</a>. You can also make comments via the website, or by email if you prefer, on the topics already included on the website.

Sharing of information, being up to date on the latest developments and learning from past mistakes is very important, and we urge you to engage with this.

We have also recently met with <u>CROSS UK</u> (Collaborative Reporting for Safer Structures UK) to discuss façade safety issues. CROSS is a confidential reporting system which allow professionals working in the built environment to report on fire and structural safety issues, including those related to facades. Reporting issues allows CROSS to share lessons learned. We all have a responsibility to act if we have concerns about safety, and CROSS provides an excellent platform for this.

#### **Fire**

As previously reported, an updated issue of the <a href="CWCT/SFE guide">CWCT/SFE guide</a> was published last year and has so far been downloaded in excess of 1800 times.

We have spent time this year promoting the document beyond the façade industry, to try and ensure that as many people as possible are aware of this guidance. We think this is really important and is something that you can help us with as well – please continue to spread to word about this guidance.
