2019 Silicon Valley Modern Home Tour Special Parking & Visitation Notes

SPECIAL PARKING NOTE: HOME 2 -- 727 Westridge Drive

Parking is available on Westridge Drive. **PLEASE pull over as far as possible** to the side of the road to not cause congestion.

SPECIAL PARKING NOTE: HOME 3 -- 26301 SILENT HILLS LN

You **MUST** park on Altamont Road, near the intersection of Altamont Lane. There is **NO PARKING** on Altamont Lane or Silent Hills Lane. You will be able to see the home (due to its geographic location) from Altamont Road when you park. It is a very short walk up the road to the home.

SPECIAL PARKING NOTE: HOME 5 -- 2951 SOUTH CT

The portion of South Court where this home is located is a short dead-end street. **Please try to find parking on El Carmelo Avenue** or the stretch of South Court located to the south/east of El Carmelo Avenue.

SPECIAL PARKING NOTE: HOME 6 -- 13755 SKYLINE BLVD

There is **NO STREET PARKING** on Skyline Boulevard/ Route 35. The owners have made parking available on the property. **When you arrive, please slowly pull on to the property** and follow directions of staff.
