Terms and Conditions:

1. Only UKON DD Distributors shall be entitled to receive UKON DD or Sigma commissions and sales. To become an UKON DD Distributor, one shall enroll in the UKON DD Program and purchase UKON DD or Sigma products. UKON DD Distributors shall likewise enjoy the marketing plan. For non-UKON member-distributors, the commission will be received by the uplines since non-UKON member-distributors are not entitled to any commission from the sales of UKON DD and Sigma products.
2. The UKON DD program allows the distributor to maintain his/her SP status for 120 days for UKON DD, and 360 days for UKON Sigma, respectively, even without making direct sales of machines.
3. An issued UKON ID number shall be valid throughout each 120 and 360-day term until cancellation of UKON DD Distributorship.
4. A new UKON ID number will be issued for first time or repeat purchases. If the UKON DD purchases did not exceed three (3) times, the UKON DD Distributorship will be terminated.
5. After cancellation of UKON DD Distributorship, the applicant herein will no longer be qualified to receive commission for any UKON DD and Sigma sales. However, while no longer qualified for SP, he/she shall still be qualified for commissions based on his/her last direct machine sale.
6. The UKON DD E8PA holder price is available for distributors who are members of E8PA.
7. Three (3) UKON DD sales shall be equivalent to one (1) machine sale for purposes of the incentive bonus.
8. Return Policy – The applicant must return the product within seven (7) business days from purchase. Thereafter, the products shall be non-refundable or non-replaceable. However, used products or those with open packaging shall likewise be non-refundable or non-replaceable.
