Baby Aaradya, 1½ years, old female, patient was admitted in this hospital with old case of thermal burn large few area of non healing wound type, very large few wound over left chest + axilla, left anterior and posterior abdomen part (deep).

#### COURSE IN HOSPITAL

Patient admitted in hospital through casualty on 10.06.2020 under Dr. A. K. Verma with above mentioned complaints. After Initial evaluation as per standardised protocol treatment initiated with IV fluids, IV antibiotics, IV PPI, IV Antiemetics, Antipyretic, Analgesic and other supportive treatment also given. All necessary investigations were done. After PAC clearance patient under went surgery convetional dressing followed by large skin grafting (Donor area B/L thigh) under GA was done On 15.06.2020. Post operative period was uneventful. Alternate day dressing was done. Patient managed conservatively. Now patient condition is stable and being discharged with following advice and medication.
