



# Italy is Out

### Mario Badagliacca with Derek Duncan



Italy is Out is the fruit of the collaboration between Mario Badagliacca, the established documentary photographer, and the research team of 'Transnationalizing Modern Languages: Mobility, Identity and Translation in Modern Italian Cultures' (2014-16). This ARHC-funded project explored the implications of Italian migration in a global perspective tracing cultural transformations across borders, generations, and language.

Badagliacca visited some of the project's key locations conducting interviews with Italians or people of Italian descent before photographing them in familiar locations. The subjects of the portraits were invited to bring along three objects representing their attachment to Italy. The sheer variety of the objects which appear alongside the portraits suggest the diversity of the migrant experience. Photographs shot in London, New York, and Buenos Aires feature members of the historical Italian community, but also first generation migrants in search of opportunities not offered at home. A similar complexity emerges, more unexpectedly, in the postcolonial Italian communities of Tunis and Addis Abeba. The photographs are accompanied by essays written by members of the research team and people who have in some way participated in the project. Fiction, autobiography and academic reflection sit side by side adding to Badagliacca's multifaceted exploration of Italians abroad.

Mario Badagliacca is a freelance Sicilian photographer. He studied international relations and politics at the University 'L'Orientale' in Naples and photo-reportage and photojournalism in Rome. Along his photographic activity, he has always collaborated with non-profit organizations and been involved in humanitarian programmes. His work documents migration, life on the borders, human right violations, and social issues.



Don Paterson is one of Britain's leading contemporary poets. A popular writer as well as a formidably intelligent one, he has won both a dedicated readership and most of Britain's major poetry prizes, including the T. S. 

Hollow Palaces reminds us how poets can often be the most perceptive of guides to radical changes in society.

The 'country house poem' was born in the seventeenth century as a fruitful way of flattering potential patrons. But the genre's popularity faded — ironically, just as 'country house society' was emerging. It was only when the power and influence of the landed classes had all but ebbed away that poets returned to the theme, attracted perhaps by the buildings' irresistible dereliction, but equally by their often very personal histories.

Over 160 distinguished poets representing a diversity of class, race, gender, and generation offer fascinating perspectives on stately exteriors and interiors, gardens both wild and cultivated, crumbling ruins and the extraordinary secrets they hide. The book's dominant note is elegiac, yet comedy, satire, even strains of Gothic can be heard among these potent reflections.



# Speculative Epistemologies

An Eccentric Account of SF from the 1960s to the Present

John Rieder

Speculative Epistemologies is about truth effects in sf, which stands for both science fiction and speculative fiction.

It examines six narratives, one from each decade from the 1960s to the 2010s, that challenge dominant assumptions about the normal, the possible, and the real. It asks what the patterns of overlap and interference generated by texts located in border territories that make their identification as sf problematic, and sometimes controversial, can reveal about the dynamics of sf's multiple subcultures (e.g. professionals, academics, and fans); the complexity of the genre's communities of practice and their routes of production, distribution, and reception; and the genre's shifting position within a broadly conceived field of literary and cultural production.

The "speculative epistemologies" in these stories are counter-hegemonic ways of knowing, ways of imagining knowing differently, and the focus of this study is their effect on the formation of identities and communities. Combining the methods of genre theory, reception theory, and the sociology of cultural production, the readings of these six narratives trace a history of sf's increasingly feminist, racially and ethnically diverse, philosophically ambitious, and politically engaged character from the 1960s to the present.


# Shakespeare and Science Fiction

Sarah Annes Brown

In Shakespeare and Science Fiction Sarah Annes Brown investigates why so many science fiction writers have turned to Shakespeare when imagining humanity's future.

He and his works become a kind of touchstone for the species in much science fiction, both transcending and exemplifying what it means to be human. Writers have used Shakespeare in a range of often contradictory ways. He is associated with freedom and with tyranny, with optimistic visions of space exploration and with the complete destruction of the human race. His works have been invoked to justify the existence of humanity, but have also frequently been coopted for their own purposes by alien life forms or artificial intelligences.

Shakespeare and Science Fiction is the first extended study of Shakespeare's influence on the genre. It engages with over a hundred works across different science fiction media, identifying recurring patterns — and telling contradictions — in the way the genre engages both with the historical Shakespeare and with his plays. It includes discussions of time travel, alternate history, dystopias, space opera, posthuman identity and post-apocalyptic fiction.

This new critical edition is designed to offer the maximum support for the reader of the poem. The text is accompanied by a close translation, and each of the twenty sections of the poem is provided with an introductory headnote as well as a running commentary. A general introduction supplies the necessary background information, on manuscript and authorship, form and structure, sources and influences, style, vocabulary and verse-form. The bibliography selects the most significant of the extensive critical studies.

Written for both the specialist and the general reader, this book is an essential guide to this profound and complex poem. Designed as a replacement for E. V. Gordon's standard edition of 1953 this is the only edition of *Pearl* to be accompanied by a literal translation and a full literary commentary and is the fruit of the author's 40 years of teaching medieval literature.
