Among the renewals for 2024 were sixteen new Lifetime memberships. This was four times more than we had expected! We now have 39 Lifetime members, over half of whom have joined in the past two years. Want to Know More About Gardening with Native Plants?

Lake shorelines change naturally over time because of bombardment by waves and ice movement — and though there was not ice on Gull or Little Long Lakes for long this winter, there was lots of damage to the shorelines when it went out. Both waves and ice can cause erosion of the shoreline and decrease water clarity and quality. The best way to prevent this type of damage to a shoreline is to remove seawalls and restore native vegetation to these areas. It's good for water quality, native aquatic plants and animals (especially fish) and looks great too!

Homeowners often ask, "How do I improve my shoreline?" Fortunately, there are lots of organizations in the area with expertise on how to enhance your shoreline and create gardens with more native plants. A great place to start is the resources available from the Michigan Natural Shoreline Partnership (https://www.shorelinepartnership.org/erosion-at-the-shoreline.html).

The Kalamazoo Area Wild Ones is a great local resource. Their website (https://kalamazoo.wildones.org/) has lots of information about opportunities for hands on learning about gardening with native plants. They also offer informational programs throughout the year; the Pints and Native Plants gathering looks like lots of fun! And don't forget to check out the GLQO website (www.glqo.net) for information. On our Resources for Lake Lovers page, we have posted links to organizations that can help you enhance your shoreline.

Or maybe you just want to see some examples to get inspired? If so, take a walk along the native shoreline demonstration plots at the WK Kellogg Biological Station (next to Windmill Island). You can also see examples of native gardens and landscaping at the KBS Bird Sanctuary, The Kalamazoo Nature Center, Richland Area Community Center, and Gilmore Car Museum.

GLQO Financial Summary



Generous support from our members, as well as significant donations for the Fall Fling, resulted in higher-than-expected income to the Gull Lake Quality in 2023. Memberships - Regular, Business and Lifetime - continue to be the primary income to the GLQO (78% in 2023). Income from memberships got a big boost from Lifetime Memberships this year – a total of 16, nine of which came in the last quarter. This is four times higher than we had expected! It is heartening to see that members make this level of commitment to the GLQO. We also had higher than expected donations this year, primarily in conjunction with the Fall Fling. A total of 21 businesses and organizations showed their support for the GLQO by contributing almost \$4500 in donations and gifts to this event.


Expenditures for 2023 were primarily in support of our work to monitor and protect water quality in Gull Lake, including management of invasive aquatic plant species. Our efforts to control the spread of invasive species in Gull Lake has been successful, because we annually monitor the lake and treat areas where the invasive species are detected. We also work to limit the introduction of invasive species into (and from) Gull Lake by operating a boat wash at Prairieville Township Park. This past year we increased our expenditures on Outreach and Educational activities, with the aim of informing people of what we do and why. We are seeing an increase in the number of new memberships in 2024 which we expect reflects these efforts.

While we ended 2023 with a comfortable surplus, we are planning a more intensive full lake monitoring for invasive species in 2024 and to expand our outreach efforts, particularly to those who are new to Gull Lake and other lakes in our area. We appreciate input from our members as to any ideas you have for expanding our visibility to both residents and visitors to Gull Lake - Keeping it Clean is our goal!

What's Happening to the Ice?



For the second year in a row, ice cover on Gull Lake and other local lakes was minimal at best. Gone once again was the annual winter ritual of ice shanties and smelt fishing on the north end of Gull Lake. Even the south bay hosted ice fishing for only a short time. Looking at the 100+ year record of ice cover on Gull Lake (see graph), we can see that 2023-2024 was among the shortest periods of ice cover in the last century. This trend of declining ice cover on Gull Lake mirrors that seen in other lakes. For example, ice cover on the Great Lakes was extremely low this winter and, overall, the amount of ice on the Great Lakes has been declining about 5% per decade since 1970.

The cause of this long-term trend of declining ice duration is no mystery. Our warming planet is responsible (2023 was the Earth's hottest year on record, by a long shot). What is less certain, however, are the consequences of less ice on our lakes. Obviously, it hurts ice fishing. For example, this was the first year ever that the lake sturgeon fishing season on Black Lake was cancelled due to unsafe ice (https://www.michigan.gov/dnr/things-to-do/fishing/black-lake). Skating, ice boating and other winter lake activities were also curtailed (we had only one good weekend of ice skating on Little Long Lake).

Other, perhaps more important, long-term consequences of less ice are unknown. Our Michigan weather is strongly affected by the Great Lakes and less ice cover on the Great Lakes can lead to more lake-effect snow (witness the record lake effect snows in Buffalo, NY over the last two years). Also, thick, stable ice protects the eggs of fish species such as Lake Whitefish that incubate over winter and increases their survival. "We know that lower Great Lakes ice cover will increase coastal erosion, the frequency of extreme weather, and resuspension of nutrients that may contribute to summer algal blooms, yet there is much uncertainty in terms of climate simulations," said Dr. Mike McKay, director of University of Windsor's Great Lakes Institute for Environmental Research. One positive effect of less ice cover on the Great Lakes, however, is an increase in the length of the shipping season.

As I look out my window at Little Long Lake this February morning with sunshine, green (yes, green) grass, and 40-degree temperatures, I'm inclined to smile at the prospect of an early spring. Things are changing, some for better and some for worse, and our Michigan winters are among them.

Score the Shore in 2024!

Score the Shore is a habitat assessment program organized by the Michigan Clean Water Corps (MiCorps) that provides a numerical score of shoreline habitat quality for inland lakes. The score is determined by surveying 1000' sections for shoreline vegetation, off-shore vegetation, evidence of erosion and erosion control practices.

In 2016, GLQO volunteers, led by Mike Gallagher, conducted *Score the Shore* surveys for Gull and Little Long Lake. The Gull Lake score was low (46 out of a possible 100) was well below the average score (70.5) of 42 lakes that participated in this program from 2015-2018. Little Long Lake scored a bit better overall (79) with all 16 sections scoring Fair or Good. On both lakes, the riparian (shoreline) zone was the weakest point (35 on Gull Lake, 63 on Little Long Lake).

We're planning a repeat Score the Shore survey of Gull this summer and we want to Raise Our Score in 2024!!

We expect that given the growing interest in native shorelines and information that has been provided at GLQO annual meetings, that we will see an improvement in our score, especially for riparian zones. And you can help! It's not too late to take some actions to improve the shoreline along your lake shore. You can start small. Just mark out a few areas along your shoreline with rocks, or other decorative objects, a few feet from the lake front, remove a bit of the grass and stop mowing. You'll be surprised at how quickly nature will take its course and native plants will start to emerge. You can enhance this by planting seeds or mature plants into the 'garden'. Encourage your neighbors to do the same; scoring encompasses 1000' sections which typically have 2 to 20 homes.
